1	A BILL TO BE ENTITLED
2	AN ACT TO REQUIRE THE CONSPICUOUS DISCLOSURE OF ANY
3	MAINTENANCE FEES CHARGED FOR GIFT CARDS AND TO PROHIBIT
4	ISSUERS OF GIFT CARDS FROM CHARGING MAINTENANCE FEES FOR
5	ONE YEAR AFTER THE DATE OF PURCHASE.
6	The General Assembly of North Carolina enacts:
7	SECTION 1. Article 13 of Chapter 66 of the General Statutes is amended by
8	adding a new section to read:
9	" <u>§ 66-67.5. Requirements for maintenance fees for gift cards.</u>
10	(a) <u>Disclosure. – The seller or issuer of a gift card must conspicuously disclose</u>
11	any maintenance fee charges at the time of purchase. The disclosure must be visible or
12	the gift card itself. No person, firm, or corporation engaged in commerce shall charge
13	any maintenance fee on a gift card for one calendar year following the date of the
14	purchase of the gift card.
15	(b) Penalty. – A seller or issuer of a gift card who violates this section commit
16	an unfair trade practice under G.S. 75-1.1 and is subject to a civil penalty in accordance
17	with G.S. 75-15.2.
18	(c) Definitions. – As used in this section, the following terms mean:
19	(1) Gift card. – A record evidencing a promise, made for monetary
20	consideration, by a seller or issuer that goods or services will be
21	provided to the owner of the record to the value shown in the record. A
22	gift card includes a record that contains a microprocessor chip
23	magnetic strip, or other storage medium that is pre-funded and fo
24	which the value is adjusted upon each use, a gift certificate, a
25	stored-value card or certificate, a store card, or a prepaid long-distance
26	telephone service that is activated by a prepaid card that required

1	dialing an access number or an access code in addition to dialing the
2	phone number to which the user of the prepaid card seeks to connect.
3	(2) <u>Maintenance fee. – Any fee that the owner of the gift card is subject to</u>
4	when the gift card is redeemed, including a service or inactivity fee.
5	(d) Limitation. – The provisions of this section shall not apply to gift cards that
6	are issued by a financial institution or its operating subsidiary and that are usable at
7	multiple unaffiliated sellers of goods or services."
8	SECTION 2. This act becomes effective December 1, 2007, and applies to
9	gift cards as defined in G.S. 66-67.4, as enacted by Section 1 of this act, that are sold on
10	or after that date.
