2 AN ACT TO PROVIDE THAT A MAGISTRATE WHO HAS A CONCEALED HANDGUN 3 PERMIT MAY CARRY OR POSSESS A CONCEALED HANDGUN WHILE IN A COURTHOUSE TO DISCHARGE OFFICIAL DUTIES.

- 5 The General Assembly of North Carolina enacts: 6
 - SECTION 1. G.S. 14-269.4 reads as rewritten:

"§ 14-269.4. Weapons on State property and in courthouses.

8 It shall be unlawful for any person to possess, or carry, whether openly or concealed, any 9 deadly weapon, not used solely for instructional or officially sanctioned ceremonial purposes in 10 the State Capitol Building, the Executive Mansion, the Western Residence of the Governor, or 11 on the grounds of any of these buildings, and in any building housing any court of the General Court of Justice. If a court is housed in a building containing nonpublic uses in addition to the 12 court, then this prohibition shall apply only to that portion of the building used for court 13 14 purposes while the building is being used for court purposes.

 - Firearms in a courthouse, carried by detention officers employed by and (4c) authorized by the sheriff to carry firearms,
- State-owned rest areas, rest stops along the highways, and State-owned 30 (5) 31 hunting and fishing reservations.

Any person violating the provisions of this section shall be guilty of a Class 1 32 33 misdemeanor."
