1	A SENATE RESOLUTION HONORING THE LEADERSHIP AND FORESIGHT OF
2	THOSE NORTH CAROLINIANS WHO CREATED AND ESTABLISHED THE
3	COMMUNITY COLLEGES AND JOINING NORTH CAROLINA'S FIFTY-EIGHT
4	COMMUNITY COLLEGES AND THE COMMUNITY COLLEGES SYSTEM OFFICE
5	WHILE OBSERVING THE FIFTIETH ANNIVERSARY OF THE NORTH CAROLINA
6 7	COMMUNITY COLLEGE SYSTEM. Whereas Dr. W. Delles Harring responded to Covernor Lyther Hodges in 1957 and
8	Whereas, Dr. W. Dallas Herring responded to Governor Luther Hodges in 1957 and prepared a plan for industrial education that resulted in the establishment by the General
9	Assembly of a statewide system of industrial education centers and the creation of a system of
10	public junior colleges; and
11	Whereas, Dr. Herring worked tirelessly with Governor Terry Sanford and others to
12	merge the two systems into a comprehensive community college system encompassing
13	workforce training and college studies; and
14	Whereas, the Omnibus Higher Education Act, also known as Senate Bill 72, was
15	passed on May 17, 1963, by the General Assembly, creating the North Carolina Department of
16	Community Colleges, which included the original 20 industrial education centers, along with
17	six junior colleges and five extension units; and
18	Whereas, this act became effective on July 1, 1963; and
19 20	Whereas, in 1963, there were 31 community colleges with a total of 79,117
20 21	students; and Whereas since 1062 North Caroline has supported the growth of this education and
21	Whereas, since 1963, North Carolina has supported the growth of this education and training system into the 58 community colleges that serve all 100 North Carolina counties
22	today; and
24	Whereas, today, North Carolina community colleges serve over 850,000 students
25	annually; and
26	Whereas, the North Carolina Community College System has been recognized,
27	nationally and internationally, through the decades as a leader in workforce development; and
28	Whereas, the 58 community colleges in North Carolina have responded to the call
29	for employee preparedness for thousands of North Carolina businesses and industries; and
30	Whereas, millions of North Carolinians have taken their first steps toward technical
31	and higher education certificates, diplomas, and degrees at these colleges through the years;
32	and Whenever a supervision of Nexth Compliant families have maximal advection and
33 34	Whereas, generations of North Carolina families have received education and training that has improved their quality of life; and

2	dedication of faculty, staff, trustees, county commissioners, and State leaders; and
3	Whereas, community colleges have responded to the needs of their communities
4	through service, support, leadership, and educational efforts; and
5	Whereas, leaders at the local, State, and national levels continue to recognize
6	community colleges as offering pathways to successful careers and educational attainment; and
7	Whereas, the System serves one in eight North Carolina adults annually and
8	continues to work toward improving student success at all levels through new accountability
9	standards and a focus on data-driven policies, decisions, and performance funding; and
0	Whereas, May 17, 2013, marks the 50th anniversary of the establishment of the
1	North Carolina Community College System; Now, therefore,
2	Be it resolved by the Senate:
3	SECTION 1. The Senate honors the leadership and foresight of those North
4	Carolinians who created and established the community colleges and joins North Carolina's 58
5	community colleges and the Community Colleges System Office in observing the 50th
6	anniversary of the North Carolina Community College System.
7	<b>SECTION 2.</b> The Senate expresses appreciation for the System's contribution to
8	the workforce development of millions of North Carolinians.
9	SECTION 3. The Principal Clerk shall transmit a copy of this resolution to the
0	President of the North Carolina Community College System.
1	<b>SECTION 4.</b> This resolution is effective upon adoption.
