A BILL TO BE ENTITLED

AN ACT TO PROVIDE FURTHER REGULATORY RELIEF TO THE CITIZENS OF NORTH CAROLINA BY PROVIDING FOR VARIOUS ADMINISTRATIVE REFORMS, BY ELIMINATING CERTAIN UNNECESSARY OR OUTDATED STATUTES AND REGULATIONS AND MODERNIZING OR SIMPLIFYING CUMBERSOME OR OUTDATED REGULATIONS, BY MAKING VARIOUS OTHER STATUTORY CHANGES, AND BY UPDATING AND AMENDING CERTAIN ENVIRONMENTAL AND NATURAL RESOURCES LAWS.

The General Assembly of North Carolina enacts:

PART I. ADMINISTRATIVE REFORMS

HARDISON AMENDMENT CLARIFICATION

SECTION 1.1.(a) G.S. 150B-19.3 reads as rewritten:

"§ 150B-19.3. Limitation on certain environmental rules.

(a) An agency authorized to implement and enforce State and federal environmental laws may not adopt a rule for the protection of the environment or natural resources that imposes a more restrictive standard, limitation, or requirement than those imposed by federal law or rule, if a federal law or rule pertaining to the same subject matter has been adopted, unless adoption of the rule is required by one of the following subdivisions of this subsection. A rule required by one of the subdivisions of this subsection shall be subject to the provisions of G.S. 150B-21.3(b1) as if the rule received written objections from 10 or more persons under G.S. 150B-21.3(b2).

- (1) A serious and unforeseen threat to the public health, safety, or welfare.
- (2) An act of the General Assembly or United States Congress that expressly requires the agency to adopt rules.
- (3) A change in federal or State budgetary policy.
- (4) A federal regulation required by an act of the United States Congress to be adopted or administered by the State.
- (5) A court order.

(b) For purposes of this section, "an agency authorized to implement and enforce State and federal environmental laws" means any of the following:

- (1) The Department of Environment and Natural Resources created pursuant to G.S. 143B-279.1.



- 1 (2) The Environmental Management Commission created pursuant to
2 G.S. 143B-282.
- 3 (3) The Coastal Resources Commission established pursuant to G.S. 113A-104.
- 4 (4) The Marine Fisheries Commission created pursuant to G.S. 143B-289.51.
- 5 (5) The Wildlife Resources Commission created pursuant to G.S. 143-240.
- 6 (6) The Commission for Public Health created pursuant to G.S. 130A-29.
- 7 (7) The Sedimentation Control Commission created pursuant to G.S. 143B-298.
- 8 (8) The North Carolina Mining and Energy Commission created pursuant to
9 G.S. 143B-293.1.
- 10 (9) The Pesticide Board created pursuant to G.S. 143-436."

11 **SECTION 1.1.(b)** G.S. 150B-21.3A(a) reads as rewritten:

12 **"§ 150B-21.3A. Periodic review and expiration of existing rules.**

13 (a) Definitions. – For purposes of this section, the following definitions apply:

14 ...

15 (3) Necessary with substantive public interest. – Means any rule for which the
16 agency has received public comments within the past two years. A rule is
17 also "necessary with substantive public interest" if either or both of the
18 following applies:

19 a. ~~the~~ The rule affects the property interest of the regulated public and
20 the agency knows or suspects that any person may object to the rule.

21 b. The rule imposes a more restrictive standard, limitation, or
22 requirement than those imposed by federal law or rule, if a federal
23 law or rule pertaining to the same subject matter has been adopted."

24 **SECTION 1.1.(c)** Section 1.1(a) of this section becomes effective July 1, 2014,
25 and applies to rules adopted or readopted on or after that date. Section 1.1(b) of this section
26 becomes effective August 23, 2013, and applies to rules reviewed on or after that date.

27
28 **SCOPE OF LOCAL AUTHORITY FOR ORDINANCES**

29 **SECTION 1.2.(a)** Section 10.2 of S.L. 2013-413 is repealed.

30 **SECTION 1.2.(b)** No later than November 1, 2014, and November 1, 2015, the
31 Department of Agriculture and Consumer Services shall report to the Environmental Review
32 Commission on any local government ordinances that impinge on or interfere with any area
33 subject to regulation by the Department.

34 **SECTION 1.2.(c)** No later than November 1, 2014, and November 1, 2015, the
35 Department of Environment and Natural Resources shall report to the Environmental Review
36 Commission on any local government ordinances that impinge on or interfere with any area
37 subject to regulation by the Department.

38 **SECTION 1.2.(d)** Article 56 of Chapter 106 of the General Statutes is amended by
39 adding a new section to read:

40 **"§ 106-678. Authority of local governments to regulate fertilizers.**

41 No county or city shall adopt or continue in effect any ordinance, rule, regulation, or
42 resolution regulating the use, sale, distribution, storage, transportation, disposal, formulation,
43 labeling, registration, manufacture, or application of fertilizer. Nothing in this section shall
44 prohibit a county, city, or other political subdivision of the State from exercising its planning
45 and zoning authority under Article 19 of Chapter 160A of the General Statutes or Article 18 of
46 Chapter 153A of the General Statutes or from exercising its fire prevention or inspection
47 authority. Nothing in this section shall limit the authority of the Department of Environment
48 and Natural Resources to enforce water quality standards."

49
50 **LOTTERY OVERSIGHT COMMITTEE ELIMINATED**

51 **SECTION 1.4.(a)** G.S. 18C-172 is repealed.

1 **SECTION 1.4.(b)** G.S. 18C-115 reads as rewritten:

2 "**§ 18C-115. Reports.**

3 The Commission shall send quarterly and annual reports on the operations of the
4 Commission to the Governor, State Treasurer, ~~the Lottery Oversight Committee,~~ and to the
5 General Assembly. The reports shall include complete statements of lottery revenues, prize
6 disbursements, expenses, net revenues, and all other financial transactions involving lottery
7 funds, including the occurrence of any audit."

8
9 **REPRESENTATION OF SMALL BUSINESS ENTITIES IN ADMINISTRATIVE**
10 **APPEALS**

11 **SECTION 1.5.(a)** G.S. 150B-23(a) reads as rewritten:

12 "(a) A contested case shall be commenced by paying a fee in an amount established in
13 G.S. 150B-23.2 and by filing a petition with the Office of Administrative Hearings and, except
14 as provided in Article 3A of this Chapter, shall be conducted by that Office. The party who
15 files the petition shall serve a copy of the petition on all other parties and, if the dispute
16 concerns a license, the person who holds the license. A party who files a petition shall file a
17 certificate of service together with the petition. A petition shall be signed by a party, an
18 attorney representing a party, or other representative of the party as may specifically be
19 authorized by law, and, if filed by a party other than an agency, shall state facts tending to
20 establish that the agency named as the respondent has deprived the petitioner of property, has
21 ordered the petitioner to pay a fine or civil penalty, or has otherwise substantially prejudiced
22 the petitioner's rights and that the agency:

- 23 (1) Exceeded its authority or jurisdiction;
24 (2) Acted erroneously;
25 (3) Failed to use proper procedure;
26 (4) Acted arbitrarily or capriciously; or
27 (5) Failed to act as required by law or rule.

28 The parties in a contested case shall be given an opportunity for a hearing without undue
29 delay. Any person aggrieved may commence a contested case hereunder.

30 A local government employee, applicant for employment, or former employee to whom
31 Chapter 126 of the General Statutes applies may commence a contested case under this Article
32 in the same manner as any other petitioner. The case shall be conducted in the same manner as
33 other contested cases under this Article.

34 If the party is a small business entity, it may be represented by one or more of its owners
35 with the written consent of all the owners, and the Office of Administrative Hearings may not
36 require that the entity retain or be represented by an attorney. A small business entity is a
37 limited liability company or a corporation that is owned, directly or indirectly, by no more than
38 two individuals. An individual is an indirect owner if the individual is a member or shareholder
39 of a limited liability company or a corporation that is an owner of the small business entity."

40 **SECTION 1.5.(b)** G.S. 105-290 is amended by adding a new subsection to read:

41 "(d2) Small Business Entity Representation. – If a property owner is a small business
42 entity, that entity may be represented by one or more of its owners with the written consent of
43 all the owners, and the Commission may not require that the entity retain or be represented by
44 an attorney. A small business entity is a limited liability company or a corporation that is
45 owned, directly or indirectly, by no more than two individuals. An individual is an indirect
46 owner if the individual is a member or shareholder of a limited liability company or a
47 corporation that is an owner of the small business entity."

48 **SECTION 1.5.(c)** This section is effective when it becomes law and applies to
49 contested cases and appeals commenced on or after that date.

50

EXEMPT SMALL BUSINESS ENTITIES BUYING OR SELLING ENTITY-OWNED PROPERTY

SECTION 1.6.(a) G.S. 93A-2(c)(1) reads as rewritten:

"(c) The provisions of G.S. 93A-1 and G.S. 93A-2 do not apply to and do not include:

(1) Any partnership, corporation, limited liability company, association, or other business entity that, as owner or lessor, shall perform any of the acts aforesaid with reference to property owned or leased by them, where the acts are performed in the regular course of or as incident to the management of that property and the investment therein. The exemption from licensure under this subsection shall extend to the following persons when those persons are engaged in acts or services for which the corporation, partnership, limited liability company, or other business entity would be exempt hereunder:

- a. The officers and employees of an exempt corporation, the corporation.
- b. The general partners and employees of an exempt partnership, and the partnership.
- c. The managers and employees of an exempt limited liability company when said persons are engaged in acts or services for which the corporation, partnership, or limited liability company would be exempt hereunder. company.
- d. The owners of an exempt closely held business entity. For purposes of this subdivision, a closely held business entity is a limited liability company or a corporation with no more than two legal owners.
- e. The officers, managers, and employees of a closely held business entity owned by a person exempt under sub-subdivision d. of this subdivision."

REDUCE STATE AGENCY MOBILE DEVICE REPORTING FREQUENCY

SECTION 1.7 Subsection 6A.14(a) of Session Law 2011-145 reads as rewritten:

"SECTION 6A.14.(a) Every executive branch agency within State government shall develop a policy to limit the issuance and use of mobile electronic devices to the minimum required to carry out the agency's mission. By September 1, 2011, each agency shall provide a copy of its policy to the Chairs of the Appropriations Committee and the Appropriations Subcommittee on General Government of the House of Representatives, the Chairs of the Appropriations/Base Budget Committee and the Appropriations Committee on General Government and Information Technology of the Senate, the Chairs of the Joint Legislative Oversight Committee on Information Technology, the Fiscal Research Division, and the Office of State Budget and Management.

State-issued mobile electronic devices shall be used only for State business. Agencies shall limit the issuance of cell phones, smart phones, and any other mobile electronic devices to employees for whom access to a mobile electronic device is a critical requirement for job performance. The device issued and the plan selected shall be the minimum required to support the employees' work requirements. This shall include considering the use of pagers in lieu of a more sophisticated device. The requirement for each mobile electronic device issued shall be documented in a written justification that shall be maintained by the agency and reviewed annually. All State agency heads, in consultation with the Office of Information Technology Services and the Office of State Budget and Management, shall document and review all authorized cell phone, smart phone, and other mobile electronic communications device procurement, and related phone, data, Internet, and other usage plans for and by their employees. Agencies shall conduct periodic audits of mobile device usage to ensure that State

1 employees and contractors are complying with agency policies and State requirements for their
2 use.

3 Beginning October 1, 2011, each agency shall report ~~quarterly~~ annually to the Chairs of the
4 House of Representatives Committee on Appropriations and the House of Representatives
5 Subcommittee on General Government, the Chairs of the Senate Committee on Appropriations
6 and the Senate Appropriations Committee on General Government and Information
7 Technology, the Joint Legislative Oversight Committee on Information Technology, the Fiscal
8 Research Division, and the Office of State Budget and Management on the following:

- 9 (1) Any changes to agency policies on the use of mobile devices.
- 10 (2) The number and types of new devices issued since the last report.
- 11 (3) The total number of mobile devices issued by the agency.
- 12 (4) The total cost of mobile devices issued by the agency.
- 13 (5) The number of each type of mobile device issued, with the total cost for each
14 type."

15
16 **ELIMINATE, AS OBSOLETE, THE SMALL BUSINESS CONTRACTOR**
17 **AUTHORITY, THE COMMITTEE ON DROPOUT PREVENTION, THE STATE**
18 **EDUCATION COMMITTEE, THE STATE EDUCATION COMMISSION, THE**
19 **NATIONAL HERITAGE AREA DESIGNATION COMMISSION, THE GOVERNOR'S**
20 **MANAGEMENT COUNCIL, THE BOARD OF DIRECTORS OF THE NORTH**
21 **CAROLINA CENTER FOR NURSING, THE BOARD OF CORRECTIONS; AND TO**
22 **ENCOURAGE THE CHIEF JUSTICE TO ABOLISH THE ACTUAL INNOCENCE**
23 **COMMISSION**

24 **SECTION 1.8.(a)** Part 20 of Article 10 of Chapter 143B of the General Statutes is
25 repealed.

26 **SECTION 1.8.(b)** Section 7.32(e) of S.L. 2007-323, as rewritten by Section
27 7.14(a) of S.L. 2008-107 and Section 7.19(e) of S.L. 2010-31, reads as rewritten:

28 "**SECTION 7.32.(e)** Report. – The Committee shall report to the Joint Legislative
29 Commission on Dropout Prevention and High School Graduation created in subsection (f) of
30 this section by December 1, 2007, on the grants awarded under subsection (d) of this section.
31 The Committee shall terminate July 1, 2014."

32 **SECTION 1.8.(c)** G.S. 116C-1 reads as rewritten:

33 "**§ 116C-1. Education Cabinet created.**

34 (a) The Education Cabinet is created. The Education Cabinet shall be located
35 administratively within, and shall exercise its powers within existing resources of, the Office of
36 the Governor. However, the Education Cabinet shall exercise its statutory powers
37 independently of the Office of the Governor.

38 (b) The Education Cabinet shall consist of the Governor, who shall serve as chair, the
39 President of The University of North Carolina, the State Superintendent of Public Instruction,
40 the Chairman of the State Board of Education, the President of the North Carolina Community
41 Colleges System, the Secretary of Health and Human Services, and the President of the North
42 Carolina Independent Colleges and Universities. The Education Cabinet may invite other
43 representatives of education to participate in its deliberations as adjunct members.

44 (c) The Education Cabinet shall be a nonvoting body that:

- 45 (1) Works to resolve issues between existing providers of education.
- 46 ~~(2) Sets the agenda for the State Education Commission.~~
- 47 (3) Develops a strategic design for a continuum of education programs, in
48 accordance with G.S. 116C-3.
- 49 (4) Studies other issues referred to it by the Governor or the General Assembly.

1 (d) The Office of the Governor, in coordination with the staffs of The University of
2 North Carolina, the North Carolina Community College System, and the Department of Public
3 Instruction, shall provide staff to the Education Cabinet."

4 **SECTION 1.8.(d)** G.S. 116C-2 is repealed.

5 **SECTION 1.8.(e)** Article 26 of Chapter 143 of the General Statutes is repealed.

6 **SECTION 1.8.(f)** Section 18.10 of S.L. 2001-491 reads as rewritten:

7 "**SECTION 18.10.** Notwithstanding G.S. 158-8.1, the Western North Carolina Regional
8 Economic Development Commission shall develop a regional heritage tourism plan and shall
9 present the plan to the 2002 Regular Session of the 2001 General Assembly no later than May
10 1, 2002. The National Heritage Area Designation Commission created pursuant to Section 18.4
11 of this act shall terminate July 1, 2014."

12 **SECTION 1.8.(g)** Part 24 of Article 9 of Chapter 143B is repealed.

13 **SECTION 1.8.(h)** G.S. 90-171.71 is repealed.

14 **SECTION 1.8.(i)** G.S. 143B-711 reads as rewritten:

15 "**§ 143B-711. Division of Adult Correction of the Department of Public Safety –**
16 **organization.**

17 The Division of Adult Correction of the Department of Public Safety shall be organized
18 initially to include the Post-Release Supervision and Parole Commission, ~~the Board of~~
19 ~~Correction~~, the Section of Prisons of the Division of Adult Correction, the Section of
20 Community Corrections, the Section of Alcoholism and Chemical Dependency Treatment
21 Programs, and such other divisions as may be established under the provisions of the Executive
22 Organization Act of 1973."

23 **SECTION 1.8.(j)** G.S. 143B-715 is repealed.

24 **SECTION 1.8.(k)** The North Carolina Actual Innocence Commission was
25 established by the Chief Justice of the North Carolina Supreme Court. Its primary purpose was
26 to make recommendations which would reduce or eliminate the possibility of the wrongful
27 conviction of an innocent person. In 2006, the General Assembly enacted S.L. 2006-184, which
28 established the North Carolina Innocence Inquiry Commission, as recommended by the North
29 Carolina Actual Innocence Commission. Inasmuch as it appears that the work of the Actual
30 Innocence Commission is complete, the Chief Justice of the North Carolina Supreme Court is
31 encouraged to take appropriate action to formally abolish the Commission.

32 **CLARIFY PROCESS FOR READOPTION OF EXISTING RULES**

33 **SECTION 1.9.** G.S. 150B-21.3A(d) reads as rewritten:

34 "(d) Timetable. – The Commission shall establish a schedule for the review and
35 readoption of existing rules in accordance with this section on a decennial basis as follows:

- 36 (1) With regard to the review process, the Commission shall assign by assigning
37 each Title of the Administrative Code a date by which the review required
38 by this section must be completed. In establishing the schedule, the
39 Commission shall consider the scope and complexity of rules subject to this
40 section and the resources required to conduct the review required by this
41 section. The Commission shall have broad authority to modify the schedule
42 and extend the time for review in appropriate circumstances. Except as
43 provided in ~~subsection~~ subsections (d1) and (e) of this section, if the agency
44 fails to conduct the review by the date set by the Commission, the rules
45 contained in that Title which have not been reviewed will expire. The
46 Commission shall report to the Committee any agency that fails to conduct
47 the review. The Commission may exempt rules that have been adopted or
48 amended within the previous 10 years from the review required by this
49 section. However, any rule exempted on this basis must be reviewed in
50

1 accordance with this section no more than 10 years following the last time
2 the rule was amended.

3 (2) With regard to the readoption of rules as required by sub-subdivision (c)(2)g.
4 of this section, once the final determination report becomes effective, the
5 Commission shall establish a date by which the agency must readopt the
6 rules. The Commission shall consult with the agency and shall consider the
7 agency's rule-making priorities in establishing the readoption date. The
8 agency may amend a rule as part of the readoption process. If a rule is
9 readopted without change, the agency is not required to prepare a fiscal note
10 as provided by G.S. 150B-21.4."
11

12 AUTHORIZE LICENSING BOARDS TO ADOPT RULES FOR PROFESSIONAL 13 CORPORATIONS

14 SECTION 1.10. G.S. 55B-12 reads as rewritten:

15 "§ 55B-12. Application of regulations of licensing boards.

16 (a) A professional corporation shall be subject to the applicable rules and regulations
17 adopted by, and all the disciplinary powers of, the licensing board as herein defined. Nothing in
18 this Chapter shall impair the disciplinary powers of any licensing board applicable to a licensee
19 as herein defined. No professional corporation may do any act which its shareholders as
20 licensees are prohibited from doing.

21 (b) Subject to the requirements of Article 2A of Chapter 150B of the General Statutes,
22 any licensing board subject to this Chapter may adopt rules to implement the provisions of this
23 Chapter, including any rules needed to establish fees within the limits set by this Chapter."
24

25 OCCUPATIONAL LICENSING BOARD REPORTING AMENDMENTS

26 SECTION 1.11. G.S. 93B-2 reads as rewritten:

27 "§ 93B-2. Annual reports required; contents; open to inspection; sanction for failure to 28 report.

29 (a) No later than October 31 of each year, each occupational licensing board shall file
30 electronically with the Secretary of State, the Attorney General, and the Joint ~~Regulatory~~
31 ~~Reform~~ Legislative Administrative Procedure Oversight Committee an annual report containing
32 all of the following information:

33 (1) The address of the board, and the names of its members and officers.

34 (1a) The total number of licensees supervised by the board.

35 (2) The number of persons who applied to the board for examination.

36 (3) The number who were refused examination.

37 (4) The number who took the examination.

38 (5) The number to whom initial licenses were issued.

39 (5a) The number who failed the examination.

40 (6) The number who applied for license by reciprocity or comity.

41 (7) The number who were granted licenses by reciprocity or comity.

42 (7a) The number of official complaints received involving licensed and
43 unlicensed activities.

44 (7b) The number of disciplinary actions taken against licensees, or other actions
45 taken against nonlicensees, including injunctive relief.

46 (8) The number of licenses suspended or revoked.

47 (9) The number of licenses terminated for any reason other than failure to pay
48 the required renewal fee.

49 (10) The substance of any anticipated request by the occupational licensing board
50 to the General Assembly to amend statutes related to the occupational
51 licensing board.

1 (11) The substance of any anticipated change in rules adopted by the
2 occupational licensing board or the substance of any anticipated adoption of
3 new rules by the occupational licensing board.

4 (b) No later than October 31 of each year, each occupational licensing board shall file
5 electronically with the Secretary of State, the Attorney General, the Office of State Budget and
6 Management, and the ~~Joint Regulatory Reform~~ Legislative Administrative Procedure Oversight
7 Committee a financial report that includes the source and amount of all funds credited to the
8 occupational licensing board and the purpose and amount of all funds disbursed by the
9 occupational licensing board during the previous fiscal year.

10 (c) The reports required by this section shall be open to public inspection.

11 (d) The Joint Legislative Administrative Procedure Oversight Committee shall notify
12 any board that fails to file the reports required by this section. Failure of a board to comply with
13 the reporting requirements of this section by October 31 of each year shall result in a
14 suspension of the board's authority to expend any funds until such time as the board files the
15 required reports. Suspension of a board's authority to expend funds under this subsection shall
16 not affect the board's duty to issue and renew licenses or the validity of any application or
17 license for which fees have been tendered in accordance with law. Each board shall adopt rules
18 establishing a procedure for implementing this subsection and shall maintain an escrow account
19 into which any fees tendered during a board's period of suspension under this subsection shall
20 be deposited."

21 OAH ELECTRONIC FILING

22 **SECTION 1.12.(a)** Article 3 of Chapter 150B of the General Statutes is amended
23 by adding a new section to read:

24 **"§ 150B-23.3. Electronic filing.**

25 (a) In addition to any other method specified in G.S. 150B-23, documents filed and
26 served in a contested case may be filed and served electronically by means of an Electronic
27 Filing Service Provider. For purposes of this section, the following definitions apply:

28 (1) Electronic filing means the electronic transmission of the petition, notice of
29 hearing, pleadings, or any other documents filed in a contested case with the
30 Office of Administrative Hearings, as further defined by rules adopted by the
31 Office of Administrative Hearings.

32 (2) Electronic Filing Service Provider (EFSP) means the service provided by the
33 Office of Administrative Hearings for e-filing and e-service of documents
34 via the Internet.

35 (3) Electronic service means the electronic transmission of the petition, notice of
36 hearing, pleadings, or any other documents in a contested case, as further
37 defined by rules adopted by the Office of Administrative Hearings."

38 **SECTION 1.12.(b)** This section is effective when it becomes law and applies to
39 contested cases filed on or after that date.

40 STATE BOARD OF EDUCATION RULEMAKING CLARIFICATION

41 **SECTION 1.13.(a)** G.S. 115C-12 reads as rewritten:

42 **"§ 115C-12. Powers and duties of the Board generally.**

43 The general supervision and administration of the free public school system shall be vested
44 in the State Board of Education. The State Board of Education shall establish policy for the
45 system of free public schools, subject to laws enacted by the General Assembly. The State
46 Board of Education is subject to Article 2A of Chapter 150B of the General Statutes. The State
47 Board of Education may not implement or enforce against any person a policy that meets the
48 definition of a rule contained in G.S. 150B-2(8a) if the policy has not been adopted as a rule in
49
50

1 accordance with Article 2A of Chapter 150B of the General Statutes. The powers and duties of
2 the State Board of Education are defined as follows:

4 **SECTION 1.13.(b)** G.S. 150B-23 is amended by adding a new subsection to read:

5 "(a4) If an agency fails to take any required action within the time period specified by
6 law, any person whose rights are substantially prejudiced by the agency's failure to act may
7 commence a contested case in accordance with this section seeking an order that the agency act
8 as required by law. If the administrative law judge finds that the agency has failed to act as

34 has exhausted all resources, internal and external, to otherwise prepare the required fiscal note.

37 request for the note. If the Office of State Budget and Management fails to prepare a fiscal note

40 Budget and Management.

46 official having administrative responsibilities under this Article of such
47 responsibilities for willful failure to obey an order, rule, or regulation

50 environmental document or permit issued under Articles 1, 4, and 7 of
51 Chapter 113A of the General Statutes for the repair, protection, safety

3 unincorporated inhabited area bordering the Atlantic Ocean or any coastal

25 of the proposed sale, the opening and terminating dates of any previous distress sale or
26 closing-out sale held by the applicant within that county during the preceding 12 months, a
27 complete inventory of the goods, wares or merchandise actually on hand in the place ~~whereat~~
28 ~~such~~where the sale is to be conducted, and all details necessary to locate exactly and identify
29 fully the goods, wares or merchandise to be sold. Provided, the seller in a distress sale need not
30 file an inventory.

31 (b) If ~~such clerk~~the designated officer shall be satisfied from said application that the
32 proposed sale is of the character which the applicant desires to advertise and conduct, the ~~clerk~~
33 designated officer shall issue a license, upon the payment of a fee of fifty dollars (\$50.00)
34 therefor, together with a bond, payable to the city or town or county in the penal sum of five
35 hundred dollars (\$500.00), conditioned upon compliance with this Article, to the applicant
36 authorizing him to advertise and conduct a sale of the particular kind mentioned in the
37 application. The license fee provided for herein shall be good for a period of 30 days from its
38 date, and if the applicant shall not complete said sale within said 30-day period then the
39 applicant shall make application to ~~such clerk~~the designated officer for a license for a new

41 of fifty dollars (\$50.00), and a second extension period of 30 days may be similarly applied for

44 bona fide sale of the kind contemplated by this Article and is acting in a bona fide manner;
45 provided, however, that the ~~clerk~~designated officer may not grant an extension period as
46 provided in this subsection if (i) the applicant conducted a distress sale immediately preceding
47 the current sale for which the extension is applied for and (ii) the period of the extension
48 applied for, when added to the period of the preceding sale and the period of the current sale,
49 will exceed 120 days. No additional bond shall be required in the event of one or more
50 extensions as herein provided for. Any merchant who shall have been conducting a business in

23 SECTION 3.1.(c) The Environmental Management Commission shall adopt a rule
24 to amend 15A NCAC 02H .1305 (Review of Applications) consistent with subsection (b) of
25 this section. Notwithstanding G.S. 150B-19(4), the rule adopted by the Commission pursuant to
26 this section shall be substantively identical to the provisions of subsection (b) of this section.
27 Rules adopted pursuant to this section are not subject to Part 3 of Article 2A of Chapter 150B
28 of the General Statutes. Rules adopted pursuant to this section shall become effective as

- 49 (2) Possess malt beverages manufactured during the brewing, distillation, and
50 fermentation program for the purpose of conducting malt beverage tasting
51 seminars and classes for students who are 21 years of age or older.

1 (3) Sell malt beverages produced during the course to wholesalers or to retailers
2 upon obtaining a malt beverages wholesaler permit under G.S. 18B-1109,
3 except that the permittee may not receive shipments of malt beverages from
4 other producers.

5 (4) Sell malt beverages produced during the course, upon obtaining a permit
6 under G.S. 18B-1001(2).

7 (b) Limitation. – Authorization for a brewing, distillation, and fermentation course shall
8 be granted by the Commission only for a community college or college that offers a brewing,
9 distillation, and fermentation program as a part of its curriculum offerings for students of the
10 school. For purposes of this section, the term "brewing, distillation, and fermentation program"
11 includes a fermentation sciences program offered by a community college or college as part of
12 its curriculum offerings for students of the school.

13 (c) Malt Beverage Special Event Permit. – The holder of a brewing, distillation, and
14 fermentation course authorization who obtains a malt beverages wholesaler permit under
15 G.S. 18B-1109 subject to the limitation in subsection (a) of this section may obtain a malt
16 beverage special event permit under G.S. 18B-1114.5 and where the permit is valid may
17 participate in approved events and sell at retail at those events any malt beverages produced
18 incident to the operation of the brewing, distillation, and fermentation program. The holder of a
19 brewing, distillation, and fermentation course authorization may participate in not more than
20 six malt beverage special events within a 12-month period and may sell up to 64 cases of malt
21 beverages, or the equivalent volume of 64 cases of malt beverages, at each event. For purposes
22 of this subsection, a "case of malt beverages" is a package containing not more than 24
23 12-ounce bottles of malt beverage. Net proceeds from the program's retail sale of malt
24 beverages pursuant to this subsection shall be retained by the school and used for support of the
25 brewing, distillation, and fermentation program.

26 (d) Limited Application. – The holder of a brewing, distillation, and fermentation
27 course authorization shall not be considered a brewery for the purposes of this Chapter or
28 Chapter 105 of the General Statutes."

29 **SECTION 3.2.(b)** G.S. 18B-1114.5(a) reads as rewritten:

30 "(a) Authorization. – The holder of a ~~brewery~~brewery permit, a malt beverage
31 ~~importer~~beverages importer permit, a brewing, distillation, and fermentation course
32 authorization, or a nonresident malt beverage vendor permit may obtain a malt beverage special
33 event permit allowing the permittee to give free tastings of its malt beverages and to sell its
34 malt beverages by the glass or in closed containers at trade shows, conventions, shopping
35 malls, malt beverage festivals, street festivals, holiday festivals, agricultural festivals, balloon
36 races, local fund-raisers, and other similar events approved by the Commission. Except for a
37 brewery operating under the provisions of G.S. 18B-1104(7), all malt beverages sampled or
38 sold pursuant to this section must be purchased from a licensed malt beverages wholesaler."

39 **SECTION 3.2.(c)** G.S. 18B-1001(2) reads as rewritten:

40 "**§ 18B-1001. Kinds of ABC permits; places eligible.**

41 When the issuance of the permit is lawful in the jurisdiction in which the premises are

49 the premises, complies with 4 NCAC 2T.0303, 4 NCAC 2T.0305, and 4
50 NCAC 2T.0308(d)-(e), and the container identifies the permittee and the
51 date the container was filled or refilled, and (iii) the holder of the permit to

1 ship malt beverages in closed containers to individual purchasers inside and
2 outside the State. The permit may be issued for any of the following:

- 3 a. ~~Restaurants; Restaurants.~~
4 b. ~~Hotels; Hotels.~~
5 c. ~~Eating establishments; establishments.~~
6 d. ~~Food businesses; businesses.~~
7 e. Retail businesses.
8 f. The holder of a brewing, distillation, and fermentation course
9 authorization under G.S. 18B-1114.6. A school obtaining a permit
10 under this subdivision is authorized to sell malt beverages
11 manufactured during its brewing, distillation, and fermentation
12 program at one noncampus location in a county where the permittee
13 holds and offers classes on a regular full-time basis in a facility
14 owned by the permittee.

16 **SECTION 3.2.(d)** G.S. 66-58(c)(1a) reads as rewritten:

28 **SECTION 3.3.(a)** Section 19(c) of Session Law 2013-413 is repealed.

29 **SECTION 3.3.(b)** Section 19(e) of Session Law 2013-413 reads as rewritten:

30 "**SECTION 19.(e)** This section is effective when it becomes law, except that ~~(i) subsection~~
31 ~~(b) of this section becomes effective October 1, 2013, and expires October 1, 2014; and (ii)~~
32 ~~subsection (c) of this section becomes effective October 1, 2014.~~subsection (b) of this section
33 becomes effective October 1, 2013."

34 **SECTION 3.3.(c)** G.S. 143-138(b2) reads as rewritten:

35 "(b2) Carbon Monoxide ~~Detectors; Alarms.~~ – The Code (i) may contain provisions
36 requiring the installation of either battery-operated or electrical carbon monoxide
37 ~~detectors;alarms~~ in every dwelling unit having a ~~fossil-fuel burning~~combustion heater,
38 appliance, or fireplace, and in any dwelling unit having an attached garage and (ii) shall contain
39 provisions requiring the installation of electrical carbon monoxide ~~detectors;alarms~~ at a lodging
40 establishment. The Building Code Council may require carbon monoxide alarms in dwelling
41 units with no combustion heater, appliance, or fireplace other than a wood-burning fireplace
42 only upon (i) a finding by the Council that carbon monoxide emissions from wood-burning
43 fireplaces constitute a substantial threat to public health and safety and (ii) a report by the

46 subsection and rules adopted pursuant to this subsection shall be punishable in accordance with
47 subsection (h) of this section and G.S. 143-139. In particular, the rules shall provide:

- 48 (1) For dwelling units, carbon monoxide ~~detectors;alarms~~ shall be those listed by
49 a nationally recognized testing laboratory that is OSHA-approved to test and
50 certify to American National Standards Institute/Underwriters Laboratories
51

1 Standards ANSI/UL2034 or ANSI/UL2075 and shall be installed in
2 accordance with either the standard of the National Fire Protection
3 Association or the minimum protection designated in the manufacturer's
4 instructions, which the property owner shall retain or provide as proof of
5 compliance. A carbon monoxide ~~detector~~alarm may be combined with
6 smoke detectors if the combined ~~detector~~alarm does both of the following:
7 (i) complies with ANSI/UL2034 or ANSI/UL2075 for carbon monoxide
8 alarms and ANSI/UL217 for smoke detectors; and (ii) emits an alarm in a
9 manner that clearly differentiates between detecting the presence of carbon
10 monoxide and the presence of smoke.

11 (2) For lodging establishments, including tourist homes that provide
12 accommodations for seven or more continuous days (extended stay
13 establishments), and bed and breakfast inns and bed and breakfast homes as
14 defined in G.S. 130A-247, carbon monoxide ~~detectors~~alarms shall be
15 installed in every ~~enclosed space~~dwelling unit or sleeping unit having a
16 fossil fuel ~~burning~~combustion heater, appliance, or fireplace and in ~~any~~
17 ~~enclosed space, including a sleeping room,~~every dwelling unit or sleeping
18 unit that shares a common wall, floor, or ceiling with an ~~enclosed space~~with
19 a room having a ~~combustion~~fossil fuel burning heater, appliance, or
20 fireplace. Carbon monoxide ~~detectors~~alarms shall be (i) listed by a nationally
21 recognized testing laboratory that is ~~OSHA approved~~approved to test and
22 certify to American National Standards Institute/Underwriters Laboratories
23 (ANSI/UL) Standards ANSI/UL2034 or ANSI/UL2075, (ii) installed in
24 accordance with either the standard of the National Fire Protection
25 Association (NFPA) or the minimum protection designated in the
26 manufacturer's instructions, which the lodging establishment shall retain or
27 provide as proof of compliance, (iii) receive primary power from the
28 building's wiring, where such wiring is served from a commercial source,
29 and (iv) receive power from a battery when primary power is interrupted. A
30 carbon monoxide ~~detector~~alarms may be combined with smoke detectors if
31 the combined ~~detector~~alarm complies with the requirements of this
32 subdivision for carbon monoxide alarms and ANSI/UL217 for smoke
33 ~~detectors~~alarms. In lieu of the carbon monoxide alarms required by this
34 subsection, a carbon monoxide detection system, which includes carbon
35 monoxide detectors and audible notification appliances installed and
36 maintained in accordance with NFPA 720 shall be permitted. The carbon
37 monoxide detectors shall be listed as complying with ANSI/UL2075. For
38 purposes of this subsection, "lodging establishment" means any hotel, motel,
39 tourist home, or other establishment permitted under authority of
40 G.S. 130A-248 to provide lodging accommodations for pay to the
41 ~~public~~public, and "combustion heater, appliance, or fireplace" means any
42 heater, appliance, or fireplace that burns combustion fuels, including, but not
43 limited to, natural or liquefied petroleum gas, fuel oil, kerosene, wood, or
44 coal, for heating, cooking, drying, or decorative purposes, including, but not
45 limited to, space heaters, wall and ceiling heaters, ranges, ovens, stoves,
46 furnaces, fireplaces, water heaters, and clothes dryers. For purposes of this
47 subsection, candles and canned fuels are not considered to be combustion
48 appliances.

49 (3) The Building Code Council shall modify the NC State Building Code (Fire
50 Prevention) to regulate the provisions of this subsection in new and existing
51 lodging establishments, including hotels, motels, tourist homes that provide

1 accommodations for seven or more continuous days (extended stay
2 establishments), and bed and breakfast inns and bed and breakfast homes as
3 defined in G.S. 130A-247; provided, nothing in this subsection shall prevent
4 the Building Code Council from establishing more stringent rules regulating
5 carbon monoxide alarms or detectors for new lodging establishments,
6 including hotels, motels, tourist homes that provide accommodations for
7 seven or more continuous days (extended stay establishments), and bed and
8 breakfast inns and bed and breakfast homes as defined in G.S. 130A-247.
9 The Building Code Council shall modify the NC State Building Code (Fire
10 Prevention) minimum inspection schedule to include annual inspections of
11 new and existing lodging establishments, including hotels, motels, and
12 tourist homes that provide accommodations for seven or more continuous
13 days (extended stay establishments), and bed and breakfast inns and bed and
14 breakfast homes as defined in G.S. 130A-247 for the purpose of compliance
15 with this subsection.

16 (4) Upon discovery of a violation of this subsection that poses an imminent
17 hazard and that is not corrected during an inspection of a lodging
18 establishment subject to the provisions of G.S. 130A-248, the code official
19 responsible for enforcing the NC State Building Code (Fire Prevention) shall
20 immediately notify the local health director, or the director's designee, for
21 the county in which the violation was discovered by verbal contact and shall
22 also submit a written report documenting the violation of this subsection to
23 the local health director, or the director's designee, for the county in which
24 the violation was discovered on the next working day following the
25 discovery of the violation. Within one working day of receipt of the written
26 report documenting a violation of this subsection, the local health director,
27 or the director's designee, for the county in which the violation was
28 discovered shall investigate and take appropriate action regarding the permit
29 for the lodging establishment, as provided in G.S. 130A-248. Lodging
30 establishments having five or more rooms that are exempted from the
31 requirements of G.S. 130A-248 by G.S. 130A-250 shall be subject to the
32 penalties set forth in the NC State Building Code (Fire Prevention).

33 (5) Upon discovery of a violation of this subsection that does not pose an
34 imminent hazard and that is not corrected during an inspection of a lodging
35 establishment subject to the provisions of G.S. 130A-248, the owner or
36 operator of the lodging establishment shall have a correction period of three
37 working days following the discovery of the violation to notify the code
38 official responsible for enforcing the NC State Building Code (Fire
39 Prevention) verbally or in writing that the violation has been corrected. If the
40 code official receives such notification, the code official may reinspect the
41 portions of the lodging establishment that contained violations, but any fees
42 for reinspection shall not exceed the fee charged for the initial inspection. If
43 the code official receives no such notification, or if the results of a
44 reinspection reveal that previous violations were not corrected, the code
45 official shall submit a written report documenting the violation of this
46 subsection to the local health director, or the director's designee, for the
47 county in which the violation was discovered within three working days
48 following the termination of the correction period or the reinspection,
49 whichever is later. The local health director shall investigate and may take
50 appropriate action regarding the permit for the lodging establishment, as
51 provided in G.S. 130A-248. Lodging establishments having five or more

1 rooms that are exempted from the requirements of G.S. 130A-248 by
2 G.S. 130A-250 shall be subject to the penalties set forth in the NC State
3 Building Code (Fire Prevention)."

4 **SECTION 3.3.(d)** G.S. 130A-248 reads as rewritten:

5 "**§ 130A-248. Regulation of food and lodging establishments.**

7 (b) No establishment shall commence or continue operation without a permit or
8 transitional permit issued by the Department. The permit or transitional permit shall be issued
9 to the owner or operator of the establishment and shall not be transferable. If the establishment
10 is leased, the permit or transitional permit shall be issued to the lessee and shall not be
11 transferable. If the location of an establishment changes, a new permit shall be obtained for the
12 establishment. A permit shall be issued only when the establishment satisfies all of the
13 requirements of the ~~rules and the requirements of subsection (g) of this section.~~ rules. The
14 Commission shall adopt rules establishing the requirements that must be met before a
15 transitional permit may be issued, and the period for which a transitional permit may be issued.
16 The Department may also impose conditions on the issuance of a permit or transitional permit
17 in accordance with rules adopted by the Commission. A permit or transitional permit shall be
18 immediately revoked in accordance with G.S. 130A-23(d) for failure of the establishment to

25 ~~space, including a sleeping room, that shares a common wall, floor, or ceiling with an enclosed~~
26 ~~space having a fossil fuel burning heater, appliance, or fireplace. Carbon monoxide detectors~~
27 ~~shall be listed by a nationally recognized testing laboratory that is OSHA approved to test and~~
28 ~~certify to American National Standards Institute/Underwriters Laboratories Standards~~
29 ~~ANSI/UL2034 or ANSI/UL2075, and installed in accordance with either the standard of the~~
30 ~~National Fire Protection Association or the minimum protection designated in the~~

40 **WATER SUPPLY WATERSHED CLASSIFICATIONS**

41 **SECTION 3.4.(a)** G.S. 143-214.5 is amended by adding a new subsection to read:

42 "(c1) This subsection applies to water supply watersheds reclassified by the Commission
43 after January 1, 2012. When the Commission receives a rule-making petition under
44 G.S. 150B-20 that (i) is from a unit of local government with jurisdiction over an area affected
45 by a proposed water intake that is impacted by a reclassification to which this subsection
46 applies and (ii) requests repeal of the reclassification, the Commission shall grant the
47 rule-making petition, and the reclassification as well as any local ordinance changes required
48 under subsection (d) of this section shall be stayed until the Commission has promulgated rules
49 in response to the rule-making petition that are retroactive to the effective date of the original
50 water supply watershed reclassification."

1 **SECTION 3.4.(b)** Notwithstanding any other provision of law, a unit of local
2 government shall repeal local ordinance changes required in order to implement a water supply
3 watershed reclassification to which G.S. 143-214.5(c1), as enacted by subsection (a) of this
4 section, applies. Local governments shall repeal local ordinances as required by this section on
5 or before the date that rules adopted pursuant to G.S. 143-214.5(c1), as enacted by subsection
6 (a) of this section, become effective.

7 **SECTION 3.4.(c)** This section is effective when it becomes law and applies to any
8 petitions for rule making regarding water supply watershed reclassifications received by the
9 Environmental Management Commission on or after January 1, 2012, and prior to the effective
10 date of this section. Subsection (a) of this section expires when the Commission issues
11 permanent rules in response to a rule-making petition under G.S. 143-214.5(c1), as enacted by
12 subsection (a) of this section.

13 14 **ADA REQUIREMENTS FOR PRIVATE POOLS**

15 **SECTION 3.5.(a)** Notwithstanding Section 1109.14 of the 2012 NC State Building
16 Code (Building Code), swimming pools shall be required to be accessible only to the extent
17 required by the Americans with Disabilities Act, 42 U.S.C. § 12101 et. seq., and federal rules
18 and regulations adopted pursuant to that act.

19 **SECTION 3.5.(b)** The Building Code Council shall adopt a rule to amend Section
20 1109.14 of the 2012 NC State Building Code (Building Code) consistent with Section 3.5(a) of
21 this act.

22 **SECTION 3.5.(c)** Section 3.5(a) of this section expires on the date that the rule
23 adopted pursuant to Section 3.5(b) of this section becomes effective.

24 25 **ENVIRONMENTAL SELF AUDIT PRIVILEGE AND LIMITED IMMUNITY**

26 **SECTION 3.6.(a)** Chapter 8 of the General Statutes is amended by adding a new
27 Part to read:

28 "Part 7D. Environmental Audit Privilege and Limited Immunity.

29 **"§ 8-58.50. Purpose.**

30 (a) In order to encourage owners and operators of facilities and persons conducting
31 activities regulated under those portions of the General Statutes set forth in G.S. 8-58.52, or
32 conducting activities regulated under other environmental laws, to conduct voluntary internal
33 environmental audits of their compliance programs and management systems and to assess and
34 improve compliance with statutes, an environmental audit privilege is recognized to protect the
35 confidentiality of communications relating to voluntary internal environmental audits.

36 (b) Notwithstanding any other provisions of law, nothing in this Part shall be construed
37 to protect owners and operators of facilities and regulated persons from a criminal investigation
38 or prosecution carried out by any appropriate governmental entity.

39 (c) Notwithstanding any other provision of law, any privilege granted by this Part shall
40 apply only to those communications, oral or written, pertaining to and made in connection with
41 the environmental audit and shall not apply to the facts relating to the violation itself.

42 **"§ 8-58.51. Definitions.**

43 The following definitions apply in this Part:

44 (1) "Department" means the Department of Environment and Natural Resources.

45 (2) "Environmental audit" means a voluntary, internal evaluation or review of
46 one or more facilities or an activity at one or more facilities regulated under
47 federal, State, regional, or local environmental law, or of compliance
48 programs, or management systems related to the facility or activity if
49 designed to identify and prevent noncompliance and to improve compliance
50 with these laws. For the purposes of this Part, an environmental audit does
51 not include an environmental site assessment of a facility conducted solely

1 in anticipation of the purchase, sale, or transfer of the business or facility. An
2 environmental audit may be conducted by the owner or operator, the parent
3 corporation of the owner or operator or by their officers or employees, or by
4 independent contractors. An environmental audit must be a discrete activity
5 with a specified beginning date and scheduled ending date reflecting the
6 auditor's bona fide intended completion schedule.

7 (3) "Environmental audit report" means a document marked or identified as
8 such with a completion date existing either individually or as a compilation
9 prepared in connection with an environmental audit. An environmental audit
10 report may include field notes and records of observations, findings,
11 opinions, suggestions, recommendations, conclusions, drafts, memoranda,
12 drawings, photographs, computer-generated or electronically-recorded
13 information, maps, charts, graphs, and surveys, provided the supporting
14 information is collected or developed for the primary purpose and in the
15 course of an environmental audit. An environmental audit report, when
16 completed, may include all of the following components:

17 a. An audit report prepared by an auditor, which may include the scope
18 and date of the audit and the information gained in the audit, together
19 with exhibits and appendices and may include conclusions,
20 recommendations, exhibits, and appendices.

21 b. Memoranda and documents analyzing any portion of the audit report
22 or issues relating to the implementation of an audit report.

23 c. An implementation plan that addresses correcting past
24 noncompliance, improving current compliance, or preventing future
25 noncompliance.

26 (4) "Enforcement agencies" means the Department, any other agency of the
27 State, and units of local government responsible for enforcement of
28 environmental laws.

29 (5) "Environmental laws" means all provisions of federal, State, and local laws,
30 rules, and ordinances pertaining to environmental matters.

31 **§ 8-58.52. Applicability.**

32 This Part applies to activities regulated under environmental laws, including all of the
33 following provisions of the General Statutes, and rules adopted thereunder:

34 (1) Article 7 of Chapter 74.

35 (2) Chapter 104E.

36 (3) Article 25 of Chapter 113.

37 (4) Articles 1,4, and 7 of Chapter 113A.

38 (5) Article 9 of Chapter 130A.

39 (6) Articles 21, 21A, and 21B of Chapter 143.

40 (7) Part 1 of Article 7 of Chapter 143B.

41 **§ 8-58.53. Environmental audit report; privilege.**

42 (a) An environmental audit report or any part of an environmental audit report is
43 privileged and, therefore, immune from discovery and is not admissible as evidence in civil or
44 administrative proceedings, except as provided in G.S. 8-58.54 and G.S. 8-58.55. Provided,
45 however, all of the following documents are exempt from the privilege established by this Part:

46 (1) Information obtained by observation of an enforcement agency.

47 (2) Information obtained from a source independent of the environmental audit.

48 (3) Documents, communication, data, reports, or other information required to
49 be collected, maintained, otherwise made available, or reported to a
50 enforcement agency or any other entity by environmental laws, permit,
51 order, consent agreement, or as otherwise provided by law.

1 (4) Documents prepared either prior to the beginning of the environmental audit
2 or subsequent to the completion date of the audit report and, in all cases, any
3 documents prepared independent of the audit or audit report.

4 (5) Documents prepared as a result of multiple or continuous self-auditing
5 conducted in an effort to intentionally avoid liability for violations.

6 (6) Information which is knowingly misrepresented or misstated or which is
7 knowingly deleted or withheld from an environmental audit report, whether
8 or not included in a subsequent environmental audit report.

9 (7) Information in instances where the material shows evidence of
10 noncompliance with environmental laws, permits, orders, consent
11 agreements, and the owner or operator failed to either promptly take
12 corrective action or eliminate any violation of law identified during the
13 environmental audit within a reasonable period of time.

14 (b) If an environmental audit report or any part of an environmental audit report is
15 subject to the privilege provided for in subsection (a) of this section, no person who conducted
16 or participated in the audit or who significantly reviewed the audit report may be compelled to
17 testify regarding the audit report or a privileged part of the audit report except as provided for
18 in G.S. 8-58.53(d), 8-58.54, or 8-58.55.

19 (c) Nothing in this Part shall be construed to restrict a party in a proceeding before the
20 Industrial Commission from obtaining or discovering any evidence necessary or appropriate for
21 the proof of any issue pending in an action before the Commission, regardless of whether
22 evidence is privileged pursuant to this Part. Further, nothing in this Part shall be construed to
23 prevent the admissibility of evidence which is otherwise relevant and admissible in a
24 proceeding before the Industrial Commission, regardless of whether the evidence is privileged
25 pursuant to this Part. Provided, however, the Commission, upon motion made by a party to the
26 proceeding, may issue appropriate protective orders preventing disclosure of information
27 outside of the Commission's proceeding.

28 (d) Nothing in this Part shall be construed to circumvent the employee protection
29 provisions provided by federal or State law.

30 (e) The privilege created by this Part does not apply to criminal investigations or
31 proceedings. Where an audit report is obtained, reviewed, or used in a criminal proceeding, the
32 privilege created by this Part shall continue to apply and is not waived in civil and
33 administrative proceedings and is not discoverable or admissible in civil or administrative
34 proceedings even if disclosed during a criminal proceeding.

35 **"§ 8-58.54. Waiver of privilege.**

36 (a) The privilege established under G.S. 8-58.53 does not apply to the extent that it is
37 expressly waived in writing by the owner or operator of a facility at which an environmental
38 audit was conducted and who prepared or caused to be prepared the audit report as a result of
39 the audit.

40 (b) The audit report and information generated by the audit may be disclosed without
41 waiving the privilege established under G.S. 8-58.53 to all of the following persons:

42 (1) A person employed by the owner or operator or the parent corporation of the
43 audited facility.

44 (2) A legal representative of the owner or operator or parent corporation.

45 (3) An independent contractor retained by the owner or operator or parent
46 corporation to conduct an audit on or to address an issue or issues raised by
47 the audit.

48 (c) Disclosure of an audit report or information generated by the audit under all of the
49 following circumstances shall not constitute a waiver of the privilege established under
50 G.S. 8-58.53:

- 1 (1) Disclosure made under the terms of a confidentiality agreement between the
2 owner or operator of the facility audited and a potential purchaser of the
3 business or facility audited.
- 4 (2) Disclosure made under the terms of a confidentiality agreement between
5 governmental officials and the owner or operator of the facility audited.
- 6 (3) Disclosure made under the terms of a confidentiality agreement between a
7 customer, lending institution, or insurance company with an existing or
8 proposed relationship with the facility.

9 **"§ 8-58.55. Notification of audit.**

10 In order to assert the privilege established under G.S. 8-58.53, the owner or operator of the
11 facility conducting the environmental audit shall, upon inspection of the facility by an
12 enforcement agency, or no later than 10 working days after completion of an agency's
13 inspection, notify the enforcement agency of the existence of any audit relevant to the subject
14 of the agency's inspection, as well as the beginning date and completion date of that audit. Any
15 environmental audit report shall include a signed certification from the owner or operator of the
16 facility that documents the date the audit began and the completion date of the audit.

17 **"§ 8-58.55. Revocation of privilege in civil and administrative proceedings.**

18 In a civil or administrative proceeding, an enforcement agency may seek by motion a
19 declaratory ruling on the issue of whether an environmental audit report is privileged. The court
20 shall revoke the privilege established under G.S. 8-58.53 for an audit report if the factors set
21 forth in this section apply. In a civil proceeding, the court, after an in camera review, shall
22 revoke the privilege established under G.S. 8-58.53 if the court determines that disclosure of
23 the environmental audit report was sought after the effective date of this Part and either of the
24 following apply:

- 25 (1) The privilege is asserted for purposes of deception or evasion.
- 26 (2) The material shows evidence of significant noncompliance with applicable
27 environmental laws; the owner or operator of the facility has not promptly
28 initiated and pursued with diligence appropriate action to achieve
29 compliance with these environmental laws or has not made reasonable
30 efforts to complete any necessary permit application; and, as a result, the
31 owner or operator of the facility did not or will not achieve compliance with
32 applicable environmental laws or did not or will not complete the necessary
33 permit application within a reasonable period of time.

34 **"§ 8-58.56. Privilege in criminal proceedings.**

35 The privilege established under G.S. 8-58.53 is not applicable in any criminal proceeding.

36 **"§ 8-58.57. Burden of proof.**

37 A party asserting the privilege established under G.S. 8-58.53 has the burden of proving
38 that (i) the materials claimed as privileged constitute an environmental audit report as defined
39 by this Part and (ii) compliance has been achieved or will be achieved with a reasonable period
40 of time. A party seeking disclosure under G.S.8-58.55 has the burden of proving the condition
41 for disclosure set forth in that section.

42 **"§ 8-58.58. Stipulations; declaratory rulings.**

43 The parties to a proceeding may at any time stipulate to entry of an order directing that
44 specific information contained in an environmental audit report is or is not subject to the
45 privilege. In the absence of an ongoing proceeding, where the parties are not in agreement, an
46 enforcement agency may seek a declaratory ruling from a court on the issue of whether the
47 materials are privileged under G.S. 8-58.53 and whether the privilege, if existing, should be
48 revoked pursuant to G.S. 8-58.55.

49 **"§ 8-58.59. Construction of Part.**

50 Nothing in this Part limits, waives, or abrogates any of the following:

- 1 (1) The scope or nature of any statutory or common law privilege, including the
2 work-product privilege or the attorney-client privilege.
- 3 (2) Any existing ability or authority under State law to challenge privilege.
- 4 (3) An enforcement agency's ability to obtain or use documents or information
5 that the agency otherwise has the authority to obtain under State law adopted
6 pursuant to federally delegated programs.

7 "**§ 8-58.60. Voluntary disclosure; limited immunity from civil and administrative**
8 **penalties and fines.**

9 (a) An owner or operator of a facility is immune from imposition of civil and
10 administrative penalties and fines for a violation of environmental laws voluntarily disclosed
11 subject to the requirements and criteria set forth in this section. Provided, however, that waiver
12 of penalties and fines shall not be granted until the applicable enforcement agency has certified
13 that the violation was corrected within a reasonable period of time. If compliance is not
14 certified by the enforcement agency, the enforcement agency shall retain discretion to assess
15 penalties and fines for the violation.

16 (b) If a person or entity makes a voluntary disclosure of a violation of environmental
17 laws discovered through performance of an environmental audit, that person has the burden of
18 proving (i) that the disclosure is voluntary by establishing the elements set forth in subsection
19 (c) of this section and (ii) that the person is therefore entitled to immunity from any
20 administrative or civil penalties associated with the issues disclosed. Nothing in this section
21 may be construed to provide immunity from criminal penalties.

22 (c) For purposes of this section, disclosure is voluntary if all of the following criteria
23 are met:

- 24 (1) The disclosure is made within 14 days following a reasonable investigation
25 of the violation's discovery through the environmental audit.
- 26 (2) The disclosure is made to an enforcement agency having regulatory
27 authority over the violation disclosed.
- 28 (3) The person or entity making the disclosure initiates an action to resolve the
29 violation identified in the disclosure in a diligent manner.
- 30 (4) The person or entity making the disclosure cooperates with the applicable
31 enforcement agency in connection with investigation of the issues identified
32 in the disclosure.
- 33 (5) The person or entity making the disclosure diligently pursues compliance
34 and promptly corrects the noncompliance within a reasonable period of time.

35 (d) A disclosure is not voluntary for purposes of this section if any of the following
36 factors apply:

- 37 (1) Specific permit conditions require monitoring or sampling records and
38 reports or assessment plans and management plans to be maintained or
39 submitted to the enforcement agency pursuant to an established schedule.
- 40 (2) Environmental laws or specific permit conditions require notification of
41 releases to the environment.
- 42 (3) The violation was committed intentionally, wilfully, or through criminal
43 negligence by the person or entity making the disclosure.
- 44 (4) The violation was not corrected in a diligent manner.
- 45 (5) The violation posed or poses a significant threat to public health, safety, and
46 welfare; the environment; and natural resources.
- 47 (6) The violation occurred within one year of a similar prior violation at the
48 same facility, and immunity from civil and administrative penalties was
49 granted by the applicable enforcement agency for the prior violation.
- 50 (7) The violation has resulted in a substantial economic benefit to the owner or
51 operator of the facility.

1 (8) The violation is a violation of the specific terms of a judicial or
2 administrative order.

3 (e) If a person meets the burden of proving that the disclosure is voluntary, the burden
4 shifts to the enforcement agency to prove that the disclosure was not voluntary, based upon the
5 factors set forth in this section. The person claiming immunity from civil or administrative
6 penalties or fines under this section retains the ultimate burden of proving the violations were
7 voluntarily disclosed.

8 (f) A voluntary disclosure made pursuant to this section is subject to disclosure
9 pursuant to the Public Records Act in accordance with the provisions of Chapter 132 of the
10 General Statutes.

11 **"§ 8-58.61. Preemption of local laws.**

12 No local law, rule, ordinance, or permit condition may circumvent or limit the privilege
13 established by this Part or the exercise of the privileges or the presumption and immunity
14 established by this Part.

15 **SECTION 3.6.(b)** This section becomes effective July 1, 2014, and applies to
16 environmental audits, as defined in G.S. 8-58.51, as enacted by subsection (a) of this section,
17 that are conducted on or after that date.

18
19 **CLARIFY DEFINITION OF "CHILD CARE"**

20 **SECTION 3.7.** G.S. 110-86(2)f. reads as rewritten:

21 **"§ 110-86. Definitions.**

22 Unless the context or subject matter otherwise requires, the terms or phrases used in this
23 Article shall be defined as follows:

24 ...

25 (2) Child care. – A program or arrangement where three or more children less
26 than 13 years old, who do not reside where the care is provided, receive care
27 on a regular basis of at least once per week for more than four hours but less
28 than 24 hours per day from persons other than their guardians or full-time
29 custodians, or from persons not related to them by birth, marriage, or
30 adoption. Child care does not include the following:

31 ...

32 f. Nonpublic schools described in Part 2 of Article 39 of Chapter 115C
33 of the General Statutes that are accredited by national or regional
34 accrediting agencies with early childhood standards and that operate
35 a child care facility as defined in subdivision (3) of this section for
36 less than six and one-half hours per day either on or off the school
37 site;site. For purposes of this sub-subdivision, the "six and one-half
38 hours per day" requirement shall relate to instructional hours only
39 and shall not include before or after school programs;"
40

41 **AMBIENT AIR MONITORING**

42 **SECTION 3.9.(a)** The Department of Environment and Natural Resources shall
43 review its ambient air monitoring network and, in the next annual monitoring network plan
44 submitted to the United States Environmental Protection Agency, shall request the removal of
45 any ambient air monitors not required by applicable federal laws and regulations.

46 **SECTION 3.9.(b)** No later than September 1, 2014, the Department of
47 Environment and Natural Resources shall discontinue all ambient air monitors not required by
48 applicable federal laws and regulations if approval from the United States Environmental
49 Protection Agency is not required for the discontinuance.

50 **SECTION 3.9.(c)** Nothing in this section is intended to prevent the Department
51 from installing temporary ambient air monitors as part of an investigation of a suspected

1 violation of air quality rules, standards, or limitations or in response to an emergency situation
2 causing an imminent danger to human health and safety.

3 **SECTION 3.9.(d)** The Department of Environment and Natural Resources,
4 Division of Air Quality, shall report to the Environmental Review Commission no later than
5 November 1, 2014, on the status of the ambient air monitoring network and the Division's
6 implementation of the requirements of this section.

7 8 **GOOD SAMARITAN LAW**

9 **SECTION 3.10.** G.S. 90-21.14 reads as rewritten:

10 "**§ 90-21.14. First aid or emergency treatment; liability limitation.**

11 (a) Any person, including a volunteer medical or health care provider at a facility of a
12 local health department as defined in G.S. 130A-2 or at a nonprofit community health center or
13 a volunteer member of a rescue squad, who ~~receives no compensation for his services as an~~
14 ~~emergency medical care provider, who~~ voluntarily and without expectation of compensation
15 renders first aid or emergency health care treatment to a person who is unconscious, ill or
16 injured,

- 17 (1) When the reasonably apparent circumstances require prompt decisions and
18 actions in medical or other health care, and
19 (2) When the necessity of immediate health care treatment is so reasonably
20 apparent that any delay in the rendering of the treatment would seriously
21 worsen the physical condition or endanger the life of the person,

22 shall not be liable for damages for injuries alleged to have been sustained by the person or for
23 damages for the death of the person alleged to have occurred by reason of an act or omission in
24 the rendering of the treatment unless it is established that the injuries were or the death was
25 caused by gross negligence, wanton conduct or intentional wrongdoing on the part of the
26 person rendering the treatment. The immunity conferred in this section also applies to any
27 person who uses an automated external defibrillator (AED) and otherwise meets the
28 requirements of this section.

29 "...."

30 31 **OPEN BURNING**

32 **SECTION 3.11.(a)** The definitions set out in G.S. 143-212, G.S. 143-213, and 15A
33 NCAC 02D .1902 (Definitions) apply to this section.

34 **SECTION 3.11.(b)** 15A NCAC 02D .1903 (Open Burning Without an Air Quality
35 Permit). – Until the effective date of the revised permanent rule that the Commission is
36 required to adopt pursuant to Section 3.11(d) of this section, the Commission and the
37 Department shall implement 15A NCAC 02D .1903 (Open Burning Without an Air Quality
38 Permit) as provided in Section 3.11(c) of this section.

39 **SECTION 3.11.(c)** Implementation. – Notwithstanding Paragraph (b) of 15A
40 NCAC 02D .1903 (Open Burning Without an Air Quality Permit), no air quality permit is
41 required for the open burning of leaves, logs, stumps, tree branches, or yard trimmings if the
42 following conditions are met:

- 43 (1) The material burned originates on the premises of private residences and is
44 burned on those premises.
45 (2) There are no public pickup services available.
46 (3) Nonvegetative materials, such as household garbage, lumber, or any other
47 synthetic materials, are not burned.
48 (4) The burning is initiated no earlier than 8:00 A.M. and no additional
49 combustible material is added to the fire between 6:00 P.M. on one day and
50 8:00 A.M. on the following day.
51 (5) The burning does not create a nuisance.

- 1 (6) Material is not burned when the North Carolina Forest Service has banned
2 burning for that area.

3 The burning of logs or stumps of any size shall not be considered to create a nuisance for
4 purposes of the application of the open burning air quality permitting exception described in
5 this subsection.

6 **SECTION 3.11.(d)** Additional Rule-Making Authority. – The Commission shall
7 adopt a rule to amend 15A NCAC 02D .1903 (Open Burning Without an Air Quality Permit)
8 consistent with Section 3.11(c) of this section. Notwithstanding G.S. 150B-19(4), the rule
9 adopted by the Commission pursuant to this section shall be substantively identical to the
10 provisions of Section 3.11(c) of this act. Rules adopted pursuant to this section are not subject
11 to Part 3 of Article 2A of Chapter 150B of the General Statutes. Rules adopted pursuant to this
12 section shall become effective as provided in G.S. 150B-21.3(b1) as though 10 or more written
13 objections had been received as provided by G.S. 150B-21.3(b2).

14 **SECTION 3.11.(e)** Sunset. – Section 3.11(c) of this section expires on the date that
15 rules adopted pursuant to Section 3.11(d) of this section become effective.

16 **SECTION 3.11.(f)** Local Government Air Pollution Control Program Limitation. –
17 G.S. 143-215.112(c) is amended by adding a new subdivision to read:

18 "**§ 143-215.112. Local air pollution control programs.**

- 19 ...
- 20 (c) (1) The governing body of any county, municipality, or group of counties and
21 municipalities within a designated area of the State, as defined in this Article
22 and Article 21, subject to the approval of the Commission, is hereby
23 authorized to establish, administer, and enforce a local air pollution control
24 program for the county, municipality, or designated area of the State which
25 includes but is not limited to:
- 26 a. Development of a comprehensive plan for the control and abatement
27 of new and existing sources of air pollution;
 - 28 b. Air quality monitoring to determine existing air quality and to define
29 problem areas, as well as to provide background data to show the
30 effectiveness of a pollution abatement program;
 - 31 c. An emissions inventory to identify specific sources of air
32 contamination and the contaminants emitted, together with the
33 quantity of material discharged into the outdoor atmosphere;
 - 34 d. Adoption, after notice and public hearing, of air quality and emission
35 control standards, or adoption by reference, without public hearing,
36 of any applicable rules and standards duly adopted by the
37 Commission; and administration of such rules and standards in
38 accordance with provisions of this section.
 - 39 e. Provisions for the establishment or approval of time schedules for the
40 control or abatement of existing sources of air pollution and for the
41 review of plans and specifications and issuance of approval
42 documents covering the construction and operation of pollution
43 abatement facilities at existing or new sources;
 - 44 f. Provision for adequate administrative staff, including an air pollution
45 control officer and technical personnel, and provision for laboratory
46 and other necessary facilities.

- 47 ...
- 48 (6) No local air pollution control program may limit or otherwise regulate any
49 combustion heater, appliance, or fireplace in private dwellings. For purposes
50 of this subdivision, "combustion heater, appliance, or fireplace" means any
51 heater, appliance, or fireplace that burns combustion fuels, including, but not

1 limited to, natural or liquefied petroleum gas, fuel oil, kerosene, wood, or
2 coal, for heating, cooking, drying, or decorative purposes."

3 **SECTION 3.11.(g)** G.S. 143-215.108 is amended by adding a new subsection to
4 read:

5 "**§ 143-215.108. Control of sources of air pollution; permits required.**

6 ...
7 (j) No Power to Regulate Residential Combustion. – Nothing in this section shall be
8 interpreted to give the Commission or the Department the power to regulate any combustion
9 heater, appliance, or fireplace in private dwellings, except to the extent required by federal law.
10 For purposes of this subsection, "combustion heater, appliance, or fireplace" means any heater,
11 appliance, or fireplace that burns combustion fuels, including, but not limited to, natural or
12 liquefied petroleum gas, fuel oil, kerosene, wood, or coal, for heating, cooking, drying, or
13 decorative purposes."

14 **SECTION 3.11.(h)** G.S. 160A-193 is amended by adding a new subsection to
15 read:

16 "**§ 160A-193. Abatement of public health nuisances.**

17 (a) A city shall have authority to summarily remove, abate, or remedy everything in the
18 city limits, or within one mile thereof, that is dangerous or prejudicial to the public health or
19 public safety. Pursuant to this section, the governing board of a city may order the removal of a
20 swimming pool and its appurtenances upon a finding that the swimming pool or its
21 appurtenances is dangerous or prejudicial to public health or safety. The expense of the action
22 shall be paid by the person in default. If the expense is not paid, it is a lien on the land or
23 premises where the nuisance occurred. A lien established pursuant to this subsection shall have
24 the same priority and be collected as unpaid ad valorem taxes.

25 ...
26 (c) The authority granted by this section does not authorize the application of a city
27 ordinance banning or otherwise limiting outdoor burning to persons living within one mile of
28 the city, unless the city provides those persons with either (i) trash and yard waste collection
29 services or (ii) access to solid waste dropoff sites on the same basis as city residents."

31 **INLET HAZARD AREAS**

32 **SECTION 3.12.(a)** The definitions set out in G.S. 113A-103 apply to this section.

33 **SECTION 3.12.(b)** 15A NCAC 07H .0304 (AECs Within Ocean Hazard Areas). –
34 Until the effective date of the revised permanent rule that the Commission is required to adopt
35 pursuant to Section 3.12(d) of this section, the Commission and the Department shall
36 implement 15A NCAC 07H .0304 (AECs Within Ocean Hazard Areas) as provided in Section
37 3.12(c) of this section.

38 **SECTION 3.12.(c)** Implementation. – Notwithstanding Subparagraph (3) of 15A
39 NCAC 07H .0304 (AECs Within Ocean Hazard Areas), the Commission shall not establish any
40 inlet hazard area in any location with the following characteristics:

- 41 (1) The location is the former location of an inlet, but the inlet has been closed
42 for at least 15 years.
- 43 (2) Due to shoreline migration, the location no longer includes the current
44 location of the inlet.
- 45 (3) The location includes an inlet providing access to a State Port via a channel
46 maintained by the United States Army Corps of Engineers.

47 **SECTION 3.12.(d)** Additional Rule-Making Authority. – The Commission shall
48 adopt a rule to amend 15A NCAC 07H .0304 (AECs Within Ocean Hazard Areas) consistent
49 with Section 3.12(c) of this section. Notwithstanding G.S. 150B-19(4), the rule adopted by the
50 Commission pursuant to this section shall be substantively identical to the provisions of Section
51 3.12(c) of this act. Rules adopted pursuant to this section are not subject to Part 3 of Article 2A

1 of Chapter 150B of the General Statutes. Rules adopted pursuant to this section shall become
2 effective as provided in G.S. 150B-21.3(b1) as though 10 or more written objections had been
3 received as provided by G.S. 150B-21.3(b2).

4 **SECTION 3.12.(e)** Sunset. – Section 3.12(c) of this section expires on the date that
5 rules adopted pursuant to subsection (d) of this section become effective.

6 **SECTION 3.12.(f)** Nothing in this section is intended to prevent the Commission
7 from (i) studying any current inlet hazard area or any other area considered by the Commission
8 for designation as an inlet hazard area, (ii) designating new inlet hazard areas, or (iii)
9 modifying existing inlet hazard areas consistent with Section 3.12(c) of this act.

10 11 **HUNTING TRIALS**

12 **SECTION 3.13.(a)** G.S. 113-274 reads as rewritten:

13 **"§ 113-274. Permits.**

14 (a) As used in this Article, the word "permit" refers to a written authorization issued
15 without charge by an employee or agent of the Wildlife Resources Commission to an individual
16 or a person to conduct some activity over which the Wildlife Resources Commission has
17 jurisdiction. When sale of wildlife resources is permitted, rules or the directives of the
18 Executive Director may require the retention of invoices or copies of invoices in lieu of a
19 permit.

20 (b) Except as otherwise specifically provided, no one may engage in any activity for
21 which a permit is required without having first procured a current and valid permit.

22 (c) The Wildlife Resources Commission may issue the following permits:

23 ...

24 (3d) Field trial dog handler or judge permit. – Authorizes a person to participate
25 as a dog handler or judge in a field trial authorized under G.S. 113-291.1(d)
26 without possessing a hunting license so long as that person does not
27 participate in any hunting activities with the dog. For purposes of this
28 subdivision, the term "hunting activities" does not include field trials using
29 exclusively either domestically raised waterfowl and game birds or legally
30 taken dead game.

31"

32 **SECTION 3.13.(b)** This section becomes effective July 1, 2014.

33 **SECTION 3.14.** G.S. 143-215.22L(w) reads as rewritten:

34 "(w) Requirements for Coastal ~~Counties~~ Counties and Reservoirs Constructed by the
35 United States Army Corps of Engineers. – A petition for a certificate (i) to transfer surface
36 water to supplement ground water supplies in the 15 counties designated as the Central
37 Capacity Use Area under 15A NCAC 2E.0501, ~~or~~ (ii) to transfer surface water withdrawn from
38 the mainstem of a river to provide service to one of the coastal area counties designated
39 pursuant to G.S. 113A-103, or (iii) to withdraw or transfer water stored in any multipurpose
40 reservoir constructed by the United States Army Corps of Engineers and partially located in a
41 state adjacent to North Carolina, provided the United States Army Corps of Engineers approved
42 the withdrawal or transfer on or before July 1, 2014, shall be considered and a determination
43 made according to the following procedures:

44 (1) The applicant shall file a notice of intent that includes a nontechnical
45 description of the applicant's request and identification of the proposed water
46 source.

47 (2) The applicant shall prepare an environmental document pursuant to
48 subsection (d) of this section, except that an environmental impact statement
49 shall not be required unless it would otherwise be required by Article 1 of
50 Chapter 113A of the General Statutes.

- 1 (3) Upon determining that the documentation submitted by the applicant is
 2 adequate to satisfy the requirements of this subsection, the Department shall
 3 publish a notice of the petition in the North Carolina Register and shall hold
 4 a public hearing at a location convenient to both the source and receiving
 5 river basins. The Department shall provide written notice of the petition and
 6 the public hearing in the Environmental Bulletin, a newspaper of general
 7 circulation in the source river basin, a newspaper of general circulation in
 8 the receiving river basin, and as provided in subdivision (3) of subsection (c)
 9 of this section. The applicant who petitions the Commission for a certificate
 10 under this subdivision shall pay the costs associated with the notice and
 11 public hearing.
- 12 (4) The Department shall accept comments on the petition for a minimum of 30
 13 days following the public hearing.
- 14 (5) The Commission or the Department may require the applicant to provide any
 15 additional information or documentation it deems reasonably necessary in
 16 order to make a final determination.
- 17 (6) The Commission shall make a final determination whether to grant the
 18 certificate based on the factors set out in subsection (k) of this section,
 19 information provided by the applicant, and any other information the
 20 Commission deems relevant. The Commission shall state in writing its
 21 findings of fact and conclusions of law with regard to each factor.
- 22 (7) The Commission shall grant the certificate if it finds that the applicant has
 23 established by a preponderance of the evidence that the petition satisfies the
 24 requirements of subsection (m) of this section. The Commission may grant

41 Counties). – Until the effective date of the revised permanent rule that the Commission is
42 required to adopt pursuant to Section 3.28(d) of this section, the Commission and the
43 Department shall implement 15A NCAC 02H .1005 (Stormwater Requirements: Coastal
44 Counties) as provided in Section 3.28(c) of this section.

37 **SECTION 3.31.(a)** G.S. 89D-1 through G.S. 89D-10 are repealed.

38 **SECTION 3.31.(b)** Chapter 89D of the General Statutes is amended by adding the

39 following new sections to read:

40 "§ 89D-11. Definitions.

41 The following definitions apply in this Chapter:

- 42 (1) Board. – The North Carolina Landscape Contractors' Licensing Board.
- 43 (2) Landscape construction or contracting. – The act of providing services as a
- 44 landscape contractor, as defined in this section, for compensation or other
- 45 consideration.
- 46 (3) Landscape contractor. – Any person who, for compensation or other
- 47 consideration, does any of the following:
- 48 a. Engages in the business requiring the art, experience, ability,
- 49 knowledge, science, and skill to prepare contracts and bid for the
- 50 performance of landscape services, including installing, planting,
- 51 repairing, and managing gardens, lawns, shrubs, vines, trees, or other

1 decorative vegetation, including the finish grading and preparation of
2 plots and areas of land for decorative utilitarian treatment and
3 arrangement.

4 b. Practices the act of horticulture consultation or planting design for
5 employment purposes.

6 c. Constructs, installs, or maintains landscape drainage systems and
7 cisterns; provided the landscaping contractor makes no connection to
8 pipes, fixtures, apparatus, or appurtenances installed upon the
9 premises, or in a building, to supply water thereto or convey sewage
10 or other waste therefrom as defined in G.S. 87-21.

11 d. Designs, installs, or maintains low-voltage landscape lighting
12 systems; provided (i) the work does not exceed the scope of the
13 exception set forth in G.S. 87-43.1(7); and (ii) the low-voltage
14 lighting systems do not exceed 50 volts and constitute a Class II or
15 Class III cord and plug connected power system.

16 e. Engages in the construction of garden pools, retaining walls, walks,
17 patios, or other decorative landscape features.

18 (4) Person. – An individual, firm, partnership, association, corporation, or other
19 legal entity.

20 **"§ 89D-12. License required; use of seal; posting license.**

21 (a) Except as otherwise provided in this Chapter, no person shall engage in the practice
22 of landscape construction or contracting, use the designation "landscape contractor," or
23 advertise using any title or description that implies licensure as a landscape contractor unless
24 the person is licensed as a landscape contractor as provided by this Chapter. All landscape
25 construction or contracting performed by a partnership, association, corporation, firm, or other
26 group shall be performed under an individual who is readily available to exercise supervision
27 over the landscape construction and contracting work and who is licensed by the Board under
28 this Chapter.

29 (b) Nothing in this Chapter shall be construed to authorize a landscape contractor to
30 engage in any of the following:

31 (1) The practice of landscape architecture as defined in G.S. 89A-1.

32 (2) The practice of engineering as defined in G.S. 89C-3.

33 (3) Practice as a well contractor certified under Article 7A of Chapter 87 of the
34 General Statutes.

35 (4) The practice of irrigation contracting as defined in G.S. 89G-1.

36 (5) The practice of architecture as defined in G.S. 83A-1.

37 (6) The practice of plumbing, heating group number one, heating group number
38 two, heating group number three, fire sprinkler, or fuel piping contracting as
39 defined in G.S. 87-21; provided the landscaping contractor may install
40 piping, fittings, valves, and associated components for the purpose of
41 landscape contracting that is downstream of a potable water source,
42 groundwater source, or grey water source, and downstream of a backflow
43 prevention assembly.

44 (7) The practice of electrical contracting as defined in G.S. 87-43.

45 (c) A landscape contractor licensed under this Chapter is not required to be licensed as
46 a general contractor under Article 1 of Chapter 87 of the General Statutes if the licensed
47 landscape contractor is performing landscape construction or contracting work valued at an
48 amount greater than thirty thousand dollars (\$30,000).

49 (d) Upon licensure by the Board, each landscape contractor shall obtain a seal of the
50 design authorized by the Board and bearing the name of the licensee, the number of the license,

1 and the legend "N.C. Licensed Landscape Contractor." A landscape contractor may use the seal
2 only while the license is valid.

3 (e) Every landscape contractor issued a license under this Chapter shall display the
4 license conspicuously in the landscape contractor's place of business. Every landscape
5 contractor shall display the license number issued to the contractor by the Board on all business
6 cards, contracts, and vehicles used by the contractor in the landscape contracting business.

7 **"§ 89D-13. Exemptions.**

8 The provisions of this Chapter shall not apply to the following:

- 9 (1) Any federal, State, or local governmental agency performing landscaping on
10 public property.
- 11 (2) The North Carolina Department of Transportation (NCDOT). However, for
12 landscape installations or establishment periods for any project that exceeds
13 the current contract amount requiring performance and payment bonds
14 according to State law, NCDOT shall require a licensed landscape contractor
15 to perform the work. NCDOT, at its discretion, may require a licensed
16 landscape contractor for landscape projects of any cost.
- 17 (3) Any property owner performing landscape work on his or her own property.
- 18 (4) Any person or business owning or operating a golf course.
- 19 (5) Any landscaping work where the price of all contracts for labor, material,
20 and other items for a given job site during any consecutive 12-month period
21 is less than twenty-five thousand dollars (\$25,000). A local governmental
22 unit shall not enact a local ordinance or regulation requiring licensure for
23 landscaping work performed pursuant to this subdivision.
- 24 (6) Any person or business licensed pursuant to Article 1 of Chapter 87 of the
25 General Statutes who possesses a classification under G.S. 87-10(b) as a
26 building contractor, a residential contractor, or a public utilities contractor
27 when the contractor uses the contractor's own employees to perform
28 landscape construction or contracting. A public utilities contractor exempted
29 by this subdivision may only perform the activities described in
30 G.S. 87-10(b)(3)a.
- 31 (7) Any person or business licensed as an electrical contractor under Article 4 of
32 Chapter 87 of the General Statutes who is designing, installing, or
33 maintaining any electric work, wiring, devices, appliances, or equipment.
- 34 (8) Any person or business licensed as a plumbing contractor under Article 2 of
35 Chapter 87 of the General Statutes who is installing pipes, fixtures,
36 apparatus, or appurtenances to supply water thereto or convey sewage or
37 other waste therefrom, including the installation, repair, or maintenance of
38 water mains, water taps, services lines, water meters, or backflow prevention
39 assemblies supplying water for irrigation systems or repairs to an irrigation
40 system.
- 41 (9) A professional engineer licensed pursuant to Chapter 89C of the General
42 Statutes.
- 43 (10) A professional landscape architect licensed under Chapter 89A of the
44 General Statutes.
- 45 (11) An individual or a business engaged in any of the following activities while
46 performing that activity:
 - 47 a. Clearing and grading plots and areas of land.
 - 48 b. Erosion control.
 - 49 c. Arboriculture, including consultations on pruning and removal of
50 trees.

- 1 d. The installation of sod, seed, or plugs by sod producers certified by
2 the Plant Industry Division of the North Carolina Department of
3 Agriculture and Consumer Services.
4 e. Landscape construction performed by utilities contractors for the
5 purpose of grading and erosion control.
6 f. Lawn mowing, turf edging, and debris removal services.
7 g. Turf management or lawn care services only, including fertilization,
8 aeration, weed control, or other turf management or lawn care
9 practices other than mowing or edging.
10 h. Design, installation, and maintenance of on-site wastewater disposal
11 or reuse systems within the on-site wastewater permit specifications.

- 12 (12) Any person performing landscaping work on a farm for use in agriculture
13 production, farming, or ranching.

14 **"§ 89D-14. The North Carolina Landscape Contractors' Licensing Board.**

15 (a) There is created the North Carolina Landscape Contractors' Licensing Board. The
16 Board shall consist of nine members appointed as follows:

- 17 (1) One member appointed by the Governor who is a member of the general
18 public.
19 (2) One member appointed by the Commissioner of Agriculture pursuant to
20 recommendations from The North Carolina Green Industry Council.
21 (3) One member appointed by the Board of Directors of the North Carolina
22 Nursery and Landscape Association, Inc., who is a practicing nurseryman
23 operating a nursery certified by the North Carolina Department of
24 Agriculture and Consumer Services Plant Industry Division.
25 (4) Four members who are licensed landscape contractors in the business of
26 landscape construction or contracting. One of the four members shall be
27 appointed by the General Assembly upon the recommendation of the
28 Speaker of the House of Representatives pursuant to recommendations from
29 The North Carolina Green Industry Council; one shall be appointed by the
30 General Assembly upon the recommendation of the President Pro Tempore
31 of the Senate pursuant to recommendations from the Carolinas Irrigation
32 Association, who is also a licensed irrigation contractor; and two shall be
33 appointed by the Board of Directors of the North Carolina Nursery and
34 Landscape Association, Inc.
35 (5) One member appointed by the Board of Directors of the North Carolina
36 Chapter of the American Society of Landscape Architects who is a
37 registered landscape architect.
38 (6) One member appointed by the President of The University of North Carolina
39 from within the land grant university community who is knowledgeable in
40 landscaping methods and practices.

41 (b) All appointments shall be for three-year terms. No member shall serve more than
42 two complete consecutive terms.

43 (c) A vacancy on the Board created by death, resignation, or otherwise shall be filled in
44 the same manner as the original appointment, except that all unexpired terms of Board
45 members appointed by the General Assembly shall be filled in accordance with G.S. 120-122.
46 Appointees to fill vacancies shall serve the remainder of the unexpired term and until their
47 successors are appointed and qualified.

48 (d) The Board shall elect annually a chair and other officers as it deems necessary to
49 carry out the purposes of this Chapter and shall hold meetings at least twice a year. A majority
50 of the Board shall constitute a quorum.

1 (e) Each member of the Board may receive per diem and reimbursement for travel and
2 subsistence as set forth in G.S. 93B-5.

3 (f) The Board shall be entitled to the services of the Attorney General in connection
4 with the affairs of the Board or may, in its discretion, employ an attorney to assist or represent
5 it in the enforcement of this Chapter.

6 **"§ 89D-15. Powers and duties.**

7 The Board shall have the following powers and duties:

8 (1) Administer and enforce the provisions of this Chapter.

9 (2) Adopt, amend, or repeal rules to carry out the provisions of this Chapter.

10 (3) Examine and determine the qualifications and fitness of applicants for
11 licensure and licensure renewal.

12 (4) Issue, renew, deny, restrict, suspend, or revoke licenses.

13 (5) Reprimand or otherwise discipline licensees under this Chapter.

14 (6) Receive and investigate complaints from members of the public.

15 (7) Conduct investigations to determine whether violations of this Chapter exist
16 or constitute grounds for disciplinary action against licensees under this
17 Chapter.

18 (8) Conduct administrative hearings in accordance with Article 3A of Chapter
19 150B of the General Statutes.

20 (9) Seek injunctive relief through any court of competent jurisdiction for
21 violations of this Chapter.

22 (10) Collect fees required by G.S. 89D-21 and any other monies permitted by law
23 to be paid to the Board.

24 (11) Require licensees to file and maintain an adequate surety bond.

25 (12) Establish and approve continuing education requirements for persons
26 licensed under this Chapter.

27 (13) Employ a secretary-treasurer and any other clerical personnel the Board
28 deems necessary to carry out the provisions of this Chapter and to fix
29 compensation for employees.

30 (14) Maintain a record of all proceedings conducted by the Board and make
31 available to licensees and other concerned parties an annual report of all
32 Board action.

33 (15) Adopt and publish a code of professional conduct for all persons licensed
34 under this Chapter.

35 (16) Adopt and publish a code of minimum practice standards for landscape
36 construction and contracting.

37 (17) Adopt a seal containing the name of the Board for use on licenses and
38 official reports issued by the Board.

39 **"§ 89D-16. Application for license; qualifications; examination; issuance.**

40 (a) Upon application to the Board and payment of the required fees, an applicant for
41 licensure as a landscape contractor may sit for the examination if the applicant submits
42 evidence demonstrating the applicant's qualifications for licensure under this Chapter as
43 prescribed in rules adopted by the Board and meets all of the following qualifications:

44 (1) Is at least 18 years of age.

45 (2) Is of good moral character as determined by the Board.

46 (3) Provides evidence of business identification as required by the Board.

47 (4) Files with the Board and maintains a corporate surety bond executed by a
48 company authorized to do business in this State or an irrevocable letter of
49 credit issued by an insured institution. The surety bond or the letter of credit
50 shall be in the amount of ten thousand dollars (\$10,000). The surety bond or
51 letter of credit shall be approved by the Board as to form and shall be

1 conditioned upon the obligor faithfully conforming to and abiding by the
2 provisions of this Chapter. Any person claiming to be injured by an act of a
3 licensed landscape contractor that constitutes a violation of this Chapter may
4 institute an action to recover against the licensee and the surety.

5 (b) If the applicant meets all the qualifications in subsection (a) of this section, the
6 applicant shall be required to pass an examination administered by the Board before the Board
7 may issue the license. The Board shall establish the scope and subject matter of the
8 examination to be administered. The Board shall administer examinations at least twice a year
9 at a time and place to be determined by the Board.

10 (c) When the Board determines that an applicant has met all the qualifications for
11 licensure, submitted the required fee, and passed the examination, the Board shall issue a
12 license to the applicant.

13 **"§ 89D-17. Corporations; partnerships; persons doing business under trade name.**

14 (a) The Board may issue a license in the name of a corporation if the corporation
15 complies with the following:

16 (1) One or more officers or full-time employees, or both, empowered to act for
17 the corporation are individuals licensed under this Chapter.

18 (2) Only the officers or employees described in subdivision (1) of this
19 subsection execute contracts for landscape construction or contracting in the
20 name of a corporation and are readily available to exercise supervision over
21 the work performed pursuant to the contract.

22 (b) The Board may issue a license in the name of a limited liability company if the
23 company complies with the following:

24 (1) One or more managers, as defined in G.S. 57D-1-03, executives, or full-time
25 employees, or a combination thereof, are individuals licensed under this
26 Chapter.

27 (2) Only the managers, executives, or employees described in subdivision (1) of
28 this subsection execute contracts for landscape construction or contracting in
29 the name of the limited liability company and are readily available to
30 exercise supervision over the work performed pursuant to the contract.

31 (c) The Board may issue a license in the name of a partnership if the partnership
32 complies with the following:

33 (1) One or more general partners or full-time employees empowered to act for
34 the partnership are individuals licensed under this Chapter.

35 (2) Only the partners or employees described in subdivision (1) of this
36 subsection execute contracts for landscape construction or contracting in the
37 name of the partnership and are readily available to exercise supervision
38 over the work performed pursuant to the contract.

39 (d) The Board may issue a license in an assumed or designated trade name if the owner
40 of the business complies with the following:

41 (1) The owner or one or more full-time employees empowered to act for the
42 owner is an individual licensed under this Chapter.

43 (2) Only the persons described in subdivision (1) of this subsection execute
44 contracts for landscape construction or contracting in the assumed or
45 designated trade name of the business and are readily available to exercise
46 supervision over the work performed pursuant to the contract.

47 (e) When the Board issues a license under this section, the Board shall indicate on the
48 license the name and license number of the individual licensee connected to the corporation,
49 partnership, or business conducted under an assumed or designated trade name.

1 (f) A person licensed pursuant to this section shall be readily available to exercise
2 supervision over a contract for landscape construction or contracting until the contract is
3 completed.

4 (g) When a licensee executes a contract for landscape construction or contracting in any
5 capacity other than as a sole proprietor contracting on the licensee's own behalf, the person on
6 whose behalf the licensee is executing the contract shall be licensed under this section.

7 (h) A corporation, partnership, or person doing business under an assumed or
8 designated trade name shall notify the Board in accordance with rules adopted by the Board if
9 an individual licensee who is indicated in the license issued under this section ceases to be an
10 officer, partner, owner, or employee of the corporation, partnership, or person doing business
11 under the assumed or designated trade name. If the corporation, partnership, or person no
12 longer has an officer, general partner, owner, or employee described in subdivision (a)(1),
13 (b)(1), or (c)(1) of this section, the corporation, partnership, or person shall have 120 days from
14 the date the officer, general partner, owner, or employee ceases the relationship with the
15 corporation, partnership, or person to satisfy the requirements described in subdivision (a)(1),
16 (b)(1), or (c)(1) of this section. The Board may, in its discretion, grant the corporation,
17 partnership, or person a period greater than 120 days to satisfy the requirements described in
18 subdivision (a)(1), (b)(1), or (c)(1) of this section as it deems appropriate. After 120 days, or a
19 time period greater than 120 days as approved by the Board, if the corporation, partnership, or
20 person does not have an officer, general partner, owner, or employee as described in
21 subdivision (a)(1), (b)(1), or (c)(1) of this section, the license issued under this section is
22 automatically suspended and the corporation, partnership, or person shall cease practicing
23 landscape construction or contracting.

24 **"§ 89D-18. Licensing of nonresidents.**

25 (a) Definitions. – The following definitions apply in this section:

26 (1) Delinquent income tax debt. – The amount of income tax due as stated in a
27 final notice of assessment issued to a taxpayer by the Secretary of Revenue
28 when the taxpayer no longer has the right to contest the amount.

29 (2) Foreign corporation. – A corporation as defined in G.S. 55-1-40.

30 (3) Foreign entity. – A foreign corporation, a foreign limited liability company,

42 (c) Certificate of Authority Required. – The Board shall not issue a license for a foreign
43 corporation unless the corporation has obtained a certificate of authority from the Secretary of
44 State pursuant to Article 15 of Chapter 55 of the General Statutes. The Board shall not issue a
45 license for a foreign limited liability company unless the company has obtained a certificate of
46 authority from the Secretary of State pursuant to Article 7 of Chapter 57D of the General
47 Statutes.

48 (d) Information. – The Board, upon request, shall provide the Secretary of Revenue the
49 name, address, and tax identification number of every nonresident individual and foreign entity
50 licensed by the Board. The information to be provided under this section shall be in a form
51 required by the Secretary of Revenue.

(e) Delinquents. – If the Secretary of Revenue determines that any nonresident individual or foreign entity licensed by the Board owes a delinquent income tax debt, the Secretary of Revenue may notify the Board of the nonresident individual and foreign entity and instruct the Board not to renew the nonresident individual or foreign entity's license. The Board shall not renew the license of a nonresident individual or foreign entity identified by the Secretary of Revenue unless the Board receives a written statement from the Secretary that (i) the debt has been paid or (ii) the debt is being paid pursuant to an installment agreement.

"§ 89D-19. Reciprocity.

The Board may issue a license, without examination, to any person who is a landscape contractor licensed, certified, or registered in another state or country if the requirements for licensure, certification, or registration in the other state or country are substantially equivalent to the requirements for licensure in this State.

"§ 89D-20. License renewal and continuing education.

(a) Every license issued under this Chapter shall be renewed on or before the first day of August of each year. Any person who desires to continue to practice shall apply for a license renewal and shall submit the required fee. Licenses that are not renewed shall be automatically revoked. A license may be renewed at any time within one year after its expiration if (i) the applicant pays the required renewal fee and late renewal fee, (ii) the Board finds that the applicant has not used the license in a manner inconsistent with the provisions of this Chapter or engaged in the practice of landscape construction or contracting after notice of revocation, and (iii) the applicant is otherwise eligible for licensure under the provisions of this Chapter. When necessary, the Board may require licensees to demonstrate continued competence as a condition of license renewal.

(b) As a condition of license renewal, a licensee shall meet the continuing education requirements set by the Board. Each licensee shall complete seven continuing education units per year. The Board may suspend a licensee's license for 30 days for failure to obtain continuing education units required by this subsection. Upon payment of a reinstatement fee, submitting to the Board proof of the continuing education units required by this subsection, and payment of the license renewal fee and late renewal fee, the licensee's license shall be reinstated. Failure to request a reinstatement of the license and failure to pay the reinstatement fee, renewal fee, and late renewal fee shall result in the forfeiture of a license. Upon forfeiture, a person shall be required to submit a new application and retake the examination as provided in this Chapter.

(b) When the Board uses a testing service for the preparation, administration, or grading of examinations, the Board may charge the applicant the actual cost of the examination services and a prorated portion of the examination fee.

"§ 89D-22. Disciplinary action.

1 (a) The Board may deny, restrict, suspend, or revoke a license or refuse to issue or
2 renew a license if a licensee or applicant does any of the following:

3 (1) Employs the use of fraud, deceit, or misrepresentation in obtaining or
4 attempting to obtain a license or the renewal of a license.

5 (2) Practices or attempts to practice landscape construction or contracting by
6 fraudulent misrepresentation.

7 (3) Commits an act of gross malpractice or incompetence as determined by the
8 Board.

36 educate citizens for whom new private drinking water wells are constructed and for citizens
37 who contact local health departments regarding testing an existing well on all of the following:

- 38 (1) The scope of the testing required pursuant to this Article.
39 (2) Optional testing available pursuant to this Article.
40 (3) The limitations of both the required and optional testing.
41 (4) Minimum drinking water standards."

42 **SECTION 3.34.(c)** The Codifier of Rules shall make any conforming rule changes
43 necessary to reflect the transfer of rule-making authority under Article 10 of Chapter 130A of
44 the General Statutes from the Commission for Public Health to the Environmental Management
45 Commission.

46
47 **WELL CONTRACTOR LICENSING CHANGES**

48 **SECTION 3.35.(a)** G.S. 87-43.1 is amended by adding the following new
49 subdivision to read:

50 **"§ 87-43.1. Exceptions.**

51 The provisions of this Article shall not apply:

1 ...
2 (10) To the installation, construction, maintenance, or repair of electrical wiring,
3 devices, appliances, or equipment by a person certified as a well contractor
4 under Article 7A of this Chapter when running electrical wires from the well
5 pump to the pressure switch."

6 **SECTION 3.35.(b)** G.S. 87-98.6 reads as rewritten:

7 **"§ 87-98.6. Well contractor qualifications and examination.**

8 (a) The Commission, with the advice and assistance of the Secretary, shall establish
9 minimum requirements of education, experience, and knowledge for each type of certification
10 for well contractors and shall establish procedures for receiving applications for certification,
11 conducting examinations, and making investigations of applicants as may be necessary and
12 appropriate so that prompt and fair consideration will be given to each applicant.

13 (b) The Commission, with the advice and assistance of the Secretary, shall establish
14 minimum requirements of education, experience, and knowledge for each type of certification
15 for well contractors for the installation, construction, maintenance, and repair of electrical
16 wiring devices, appliances, and equipment related to the construction, operation, and repair of
17 wells. Requirements developed pursuant to this subsection shall apply only to the initial
18 certification of an applicant and shall not be required as part of continuing education or as a
19 condition of certification renewal."

20 **SECTION 3.35.(c)** This section is effective when it becomes law. The
21 requirements of subsection (b) of G.S. 87-98.6, as enacted by Section 3.35(b) of this section,
22 apply to applicants applying for certification on or after the date this section becomes effective.

23 24 **STANDARDIZE LOCAL WELL PROGRAMS**

25 **SECTION 3.36.(a)** G.S. 87-97 reads as rewritten:

26 **"§ 87-97. Permitting, inspection, and testing of private drinking water wells.**

27 (a) Mandatory Local Well Programs. – Each county, through the local health
28 department that serves the county, shall implement a private drinking water well permitting,
29 inspection, and testing program. Local health departments shall administer the program and
30 enforce the minimum well construction, permitting, inspection, repair, and testing requirements
31 set out in this Article and rules adopted pursuant to this Article. No person shall unduly delay
32 or refuse to permit a well that can be constructed or repaired and operated in compliance with
33 the requirements set out in this Article and rules adopted pursuant to this Article.

34 (a1) Use of Standard Forms. – Local well programs shall use the standard forms created
35 by the Department for all required submittals and shall not create their own forms unless the
36 local program submits a petition for rule making to the Environmental Management
37 Commission, and the Commission by rule finds that conditions or circumstances unique to the
38 area served by the local well program constitute a threat to public health that will be mitigated
39 by use of a local form different from the form used by the Department.

40 ...
41 (k) Registry of Permits and Test Results. – Each local health department shall maintain
42 a registry of all private drinking water wells for which a construction permit or repair permit is
43 ~~issued~~ issued that is searchable by address or addresses served by the well. The registry shall
44 specify the physical location of each private drinking water well and shall include the results of
45 all tests of water from each well. The local health department shall retain a record of the results
46 of all tests of water from a private drinking water well until the well is properly closed in
47 accordance with the requirements of this Article and rules adopted pursuant to this Article.

48"

49 **SECTION 3.36.(b)** Notwithstanding 15A NCAC 02C .0107(j)(2), neither the
50 Department of Environment and Natural Resources nor any local well program shall require
51 that well contractor identification plates include the well construction permit numbers. Local

1 well programs may install a plate with the well construction permit number or any other
2 information deemed relevant on a well at the expense of the local program.

3 **SECTION 3.36.(c)** The Environmental Management Commission shall adopt a
4 rule to amend 15A NCAC 02C .0107(j)(2) consistent with Section 3.36(b) of this section.

5 **SECTION 3.36.(d)** Section 3.36(b) of this section expires on the date that the rule
6 adopted pursuant to Section 3.36(c) of this section becomes effective.

7 **SECTION 3.36.(e)** If the well location marked on the map submitted with an
8 application to a local well program is also marked with a stake or similar marker on the
9 property, then the local well program may not require the contractor to be onsite during the
10 on-site predrill inspection, as long as the contractor is available by telephone to answer
11 questions.

12 13 **MILITARY LANDS PROTECTION ACT AND MILITARY AFFAIRS COMMISSION** 14 **AMENDMENTS**

15 **SECTION 3.37.(a)** Article 8B of Chapter 143 of the General Statutes is amended
16 by adding a new section to read:

17 **"§ 143-135.29. Review of Military Lands Protection Act Proposals.**

18 The State Construction Office shall maintain, and make available to the public, accurate
19 maps of areas surrounding major military installations, including Military Trainings Routes and
20 Military Operating Areas, as defined in G.S. 143-151.71, that are subject to the provisions of
21 Article 9G of Chapter 143 of the General Statutes."

22 **SECTION 3.37.(b)** G. S. 143-151.71 reads as rewritten:

23 **"§ 143-151.71. Definitions.**

24 Within the meaning of this Article:

- 25 (1) "Area surrounding major military installations" is the area that extends five
26 miles beyond the boundary of a major military installation and may include
27 incorporated and unincorporated areas of counties and municipalities.
- 28 (2) ~~"Building Code Council" means the Council created pursuant to Article 9 of~~
29 ~~Chapter 143 of the General Statutes.~~
- 30 (3) "Commissioner" means the Commissioner of Insurance.
- 31 (4) "Construction" includes reconstruction, alteration, or expansion.
- 32 (5) "Major military installation" means Fort Bragg, Pope Army Airfield, Camp
33 Lejeune Marine Corps Air Base, New River Marine Corps Air Station,
34 Cherry Point Marine Corps Air Station, Military Ocean Terminal at Sunny
35 Point, the United States Coast Guard Air Station at Elizabeth City, Naval
36 Support Activity Northwest, Air Route Surveillance Radar (ARSR-4) at Fort
37 Fisher, and Seymour Johnson Air Force Base, in its own right and as the
38 responsible entity for the Dare County Bombing Range, and any facility
39 located within the State that is subject to the installations' oversight and
40 control.
- 41 (6) "Person" means any individual, partnership, firm, association, joint venture,
42 public or private corporation, trust, estate, commission, board, public or
43 private institution, utility, cooperative, interstate body, the State of North
44 Carolina and its agencies and political subdivisions, or other legal entity.
- 45 (6a) "State Construction Office" means the State Construction Office of the
46 Department of Administration.
- 47 (7) "Tall buildings or structures" means any building, structure, or unit within a
48 multiunit building with a vertical height of more than 200 feet measured
49 from the top of the foundation of the building, structure, or unit and the
50 uppermost point of the building, structure, or unit. "Tall buildings or
51 structures" do not include buildings and structures listed individually or as

1 contributing resources within a district listed in the National Register of
2 Historic Places."

3 **SECTION 3.37.(c)** G.S. 143-151.73 reads as rewritten:

4 **"§ 143-151.73. Certain buildings and structures prohibited without endorsement.**

5 (a) No county or city may authorize the construction of and no person may construct a
6 tall building or structure in any area surrounding a major military installation in this State,
7 unless the county or city is in receipt of either a letter of endorsement issued to the person by
8 the ~~Building Code Council~~State Construction Office pursuant to G.S. 143-151.75 or proof of
9 the ~~Council's~~State Construction Office's failure to act within the time allowed pursuant to
10 G.S. 143-151.75.

11 (b) No county or city may authorize the provision of the following utility services to
12 any building or structure constructed in violation of subsection (a) of this section: electricity,
13 telephone, gas, water, sewer, or septic system."

14 **SECTION 3.37.(d)** G.S. 143-151.75 reads as rewritten:

15 **"§ 143-151.75. Endorsement for proposed tall buildings or structures required.**

16 (a) No person shall undertake construction of a tall building or structure in any area
17 surrounding a major military installation in this State without either first obtaining the
18 endorsement from the ~~Building Code Council~~State Construction Office or proof of the
19 ~~Council's~~State Construction Office's failure to act within the time allowed.

20 (b) A person seeking endorsement for a proposed tall building or structure in any area
21 surrounding a major military installation in this State shall provide written notice of the intent
22 to seek endorsement to the base commander of the major military installation that is located
23 within five miles of the proposed tall building or structure and shall provide all of the following
24 to the ~~Building Code Council~~State Construction Office:

- 25 (1) Identification of the major military installation and the base commander of
26 the installation that is located within five miles of the proposed tall building
27 or structure.
- 28 (2) A copy of the written notice sent to the base commander of the installation
29 identified in subdivision (1) of this subsection that is located within five
30 miles of the proposed tall building or structure.
- 31 (3) A written "Determination of No Hazard to Air Navigation" issued by the
32 Federal Aviation Administration pursuant to Subpart D of Part 77 of Title 14
33 of the Code of Federal Regulations (January 1, 2012, Edition) for the
34 proposed tall building or structure.

35 (c) After receipt of the information provided by the applicant pursuant to subsection (b)
36 of this section, the ~~Building Code Council~~State Construction Office shall, in writing, request a
37 written statement concerning the proposed tall building or structure from the base commander
38 of the major military installation identified in subdivision (1) of subsection (b) of this section.
39 The ~~Building Code Council~~State Construction Office shall request that the following
40 information be included in the written statement from the base commander:

- 41 (1) A determination whether the location of the proposed tall building or
42 structure is within a protected area that surrounds the installation.
- 43 (2) A determination whether any activities of the installation may be adversely
44 affected by the proposed tall building or structure. A detailed description of
45 the potential adverse effects, including frequency disturbances and physical
46 obstructions, shall accompany the determination required by this
47 subdivision.

48 (d) The ~~Building Code Council~~State Construction Office shall not endorse a tall
49 building or structure if the Council finds any one or more of the following:

- 50 (1) The proposed tall building or structure would encroach upon or otherwise
51 interfere with the mission, training, or operations of any major military

1 installation in North Carolina and result in a detriment to continued military
2 presence in the State. In its evaluation, the ~~Building Code Council~~State
3 Construction Office may consider whether the proposed tall building or
4 structure would cause interference with air navigation routes, air traffic
5 control areas, military training routes, or radar based on the written
6 statement received from a base commander as provided in subsection (c) of
7 this section and written comments received by members of affected
8 communities. Provided, however, if the ~~Building Code Council~~State
9 Construction Office does not receive a written statement requested pursuant
10 to subsection (c) of this section within 45 days of issuance of the request to
11 the base commander, the ~~Building Code Council~~State Construction Office
12 shall deem the tall building or structure as endorsed by the base commander.

13 (2) The ~~Council~~State Construction Office is not in receipt of the written
14 "Determination of No Hazard to Air Navigation" issued to the person by the
15 Federal Aviation Administration required pursuant to subdivision (3) of
16 subsection (b) of this section.

17 (e) The ~~Building Code Council~~State Construction Office shall make a final decision on
18 the request for endorsement of a tall building or structure within 90 days from the date on
19 which the ~~Council~~State Construction Office requested the written statement from the base
20 commander of the major military installation identified in subdivision (1) of subsection (b) of
21 this section. If the ~~Council~~State Construction Office determines that a request for a tall building
22 or structure fails to meet the requirements for endorsement under this section, the ~~Council~~State
23 Construction Office shall deny the request. The ~~Council~~State Construction Office shall notify
24 the person of the denial, and the notice shall include a written statement of the reasons for the
25 denial. If the ~~Council~~State Construction Office fails to act within any time period set forth in
26 this section, the person may treat the failure to act as a decision to endorse the tall building or
27 structure.

28 (f) The ~~Building Code Council~~State Construction Office may meet by telephone, video,
29 or Internet conference, so long as consistent with applicable law regarding public meetings, to
30 make a decision on a request for endorsement for a tall building or structure pursuant to
31 subsection (e) of this section."

32 **SECTION 3.37.(e)** G.S. 143-138(j2) is repealed.

33 **SECTION 3.38.** G.S. 127C-1 is amended by adding a new subsection to read:

34 "(d) Meetings and Records. – Notwithstanding Article 33C of Chapter 143 of the
35 General Statutes and Chapter 132 of the General Statutes, the Commission may withhold
36 documents and discussions related to the federal government's process to determine closure or
37 realignment of military installations until a final decision has been made by the federal
38 government in that process."

39 **PART IV. STUDIES**

40 **HONEYBEE WORKING GROUP**

41
42 **SECTION 4.1.(a)** The General Assembly recognizes the importance of the State's
43 agriculture sector and heritage and the importance of honeybee pollination to this sector. In an
44 effort to proactively address the issue of Colony Collapse Disorder and its damaging effects on
45 honeybee populations, the Department of Agriculture and Consumer Services shall create the
46 Honeybee Improvement for Vital Ecology (HIVE) working group. The group shall consist of
47 nine members appointed as follows:
48

49 (1) The Commissioner of Agriculture, or the Commissioner's designee, serving
50 ex officio.

- 1 (2) A representative from the Plant Protection Section of the Department of
2 Agriculture and Consumer Services.
- 3 (3) A representative from the Department of Transportation.
- 4 (4) A representative from the Utilities Commission Public Staff.
- 5 (5) Two representatives from publicly owned utilities that operate within the
6 State.
- 7 (6) Two representatives from the biotechnology sector whose company is
8 actively involved in honeybee research.
- 9 (7) One researcher from North Carolina State University, who shall be an
10 entomologist or apiculturist.

11 Vacancies in the HIVE group shall be filled by the Department of Agriculture and
12 Consumer Services. A quorum of the group shall consist of five members.

13 The HIVE group may contract for professional, clerical, or consultant services.

14 **SECTION 4.1.(b)** Purpose. – The HIVE group shall create and issue a report
15 containing the following:

- 16 (1) A list of bee-friendly vegetation and planting requirements for such
17 vegetation. The list shall include a recommendation as to the appropriateness
18 of locating each bee-friendly plant with respect to:
 - 19 a. Department of Transportation public road rights-of-way,
 - 20 b. Rights-of-way held by publicly owned utilities.
- 21 (2) Whether planting requirements for bee-friendly vegetation within
22 rights-of-way for public utilities should be voluntary or required.
- 23 (3) A recommendation from the Department of Transportation as to whether
24 priority should be given to bee-friendly vegetation for landscaping projects
25 within Department-owned rights-of-way and rest areas. Any
26 recommendation of priority shall also include a percentage breakdown of
27 urban and rural areas to be targeted.
- 28 (4) A recommendation from the Utilities Commission Public Staff, publicly
29 owned utilities, or both as to dedications of rural easements for bee-friendly
30 vegetation, including a percentage breakdown of urban and rural areas to be
31 targeted.
- 32 (5) A recommendation from the Department of Agriculture and Consumer
33 Services as to whether a statewide bee-friendly vegetation planting program
34 would be beneficial to the State's agriculture industry, including any
35 estimated benefit. In doing so, the Department of Agriculture and Consumer
36 Services shall address the following:
 - 37 a. The willingness of farms to plant bee-friendly vegetation in rural
38 areas;
 - 39 b. The ability of the Department of Agriculture and Consumer Services
40 to provide support for a farm planting program from existing funds;
41 and
 - 42 c. The ability of research stations or other properties to plant
43 bee-friendly vegetation.

44 **SECTION 4.1.(c)** Staff. – The Department of Agriculture and Consumer Services
45 shall assign professional and clerical staff to assist in the work of the HIVE group.

46 **SECTION 4.1.(d)** Report. – The HIVE group shall submit a final report to the
47 Environmental Review Commission by November 30, 2014. The report shall contain the
48 information required in this section and any findings, legislative proposals, cost/benefit
49 analyses, or additional recommendations for legislative action to proactively address Colony
50 Collapse Disorder or other honeybee-related issues that may threaten the economy, ecology,
51 and agricultural heritage of the State.

SENATOR JEAN PRESTON MARINE SHELLFISH SANCTUARY

SECTION 4.2.(a) It is the intent of the General Assembly to establish a marine shellfish sanctuary in the Pamlico Sound to be named in honor of former Senator Jean Preston, to be called the "Senator Jean Preston Marine Shellfish Sanctuary."

SECTION 4.2.(b) The Division of Marine Fisheries of the Department of Environment and Natural Resources shall designate a contiguous area of approximately 10,000 acres within the Pamlico Sound as a recommendation to the Environmental Review Commission for establishment of the "Senator Jean Preston Marine Shellfish Sanctuary" and create a plan for managing the sanctuary that includes the following components:

- (1) Location and delineation of the sanctuary. – The plan should include a location for the sanctuary that minimizes the impact on commercial trawling. In addition, the sanctuary should be gridded into areas leased to private parties for restoration and harvest and areas operated and maintained by the State for restoration that are not open for harvest. The leased and unleased areas should be arranged in a pattern where leased squares are surrounded on four sides by unleased squares.
- (2) Administration. – The plan should include the prices to be charged for the leased portions of the sanctuary, including an administration fee to be retained by the Division to support the leasing and monitoring program. The plan shall also provide that the balance of lease payments collected by the Division be transferred to the General Fund with a recommendation that some or all of the proceeds be used for the support of the State's special education programs in memory of Senator Jean Preston.
- (3) Funding. – The plan should include a request for appropriations sufficient to provide funds for the construction of appropriate bottom habitat and shellfish seeding and for Division staff necessary to conduct oyster restoration and monitoring activities. The plan should provide that, whenever possible, construction and shellfish seeding be carried out by contract with private entities.
- (4) Commercial fisherman relief. – To promote the diversification of commercial fishing opportunities, the plan should include a program to award free or discounted leases under this section to commercial fishermen who (i) have held one or more commercial fishing licenses continually for a period of 10 or more years and (ii) receive at least fifty (50%) of their income from commercial fishing with those licenses.
- (5) Recommendations. – The plan should include recommendations for statutory or regulatory changes needed to expedite the expansion of shellfish restoration and harvesting in order to improve water quality, restore ecological habitats, and expand the coastal economy.

SECTION 4.2.(c) No later than October 1, 2014, and quarterly thereafter until submission of a final plan to the Environmental Review Commission, the Department of Environment and Natural Resources shall report to the Environmental Review Commission regarding its implementation of this section and its recommended plan.

DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES TO STUDY INTERBASIN TRANSFERS

SECTION 4.3.(a) The Department of Environment and Natural Resources shall study the statutes and rules governing interbasin transfers and make recommendations as to whether the statutes and rules should be amended. The study shall specifically examine all of the following:

- 1 (1) Whether and to what extent temporary and emergency interbasin transfers,
2 including interbasin transfers to provide drought relief, should be subject to
3 different regulatory requirements than long-term interbasin transfers.
- 4 (2) Whether and to what extent interbasin transfers between river sub-basins
5 should be subject to different regulatory requirements than interbasin
6 transfers between major river basins.
- 7 (3) Whether there are types of interbasin transfers that should be exempted from
8 the interbasin certification or other regulatory requirements.

9 **SECTION 4.3.(b)** No later than October 1, 2014, the Department of Environment
10 and Natural Resources shall report its findings and recommendations to the Environmental
11 Review Commission.
12

13 **PROGRAM EVALUATION DIVISION TO STUDY WATER AND SEWER SYSTEMS**

14 **SECTION 4.4.(a)** The Joint Legislative Program Evaluation Oversight Committee
15 shall include in the 2014-2015 Work Plan for the Program Evaluation Division of the General
16 Assembly a study of the benefits that may result from the merger of public water systems and
17 wastewater collection and treatment works. The Program Evaluation Division shall specifically
18 include the following in the study:

- 19 (1) Consideration of whether the benefits that have resulted from the merger of
20 certain public water systems and certain wastewater collection and treatment
21 works can be replicated for other systems. In considering this issue, the
22 Program Evaluation Division shall investigate the performance of the
23 Charlotte-Mecklenburg Utility Department, the Cape Fear Public Utility
24 Authority, and Two Rivers Utilities.
- 25 (2) Whether the State can incentivize public water systems and wastewater
26 collection and treatment works that provide service that is affordable,
27 reliable, and in compliance with all applicable laws to purchase, to
28 interconnect with, or enter into joint management agreements with public
29 water systems and wastewater collection and treatment works that do not
30 provide service that is affordable, reliable, and in compliance with all
31 applicable laws.
- 32 (3) Whether the State can allow public water systems and wastewater collection
33 and treatment works that provide service that is affordable, reliable, and in
34 compliance with all applicable laws to apply for grant funding or other
35 assistance on the behalf of public water systems and wastewater collection
36 and treatment works that do not provide service that is affordable, reliable,
37 and in compliance with all applicable laws if the award of such funding is
38 contingent on purchase, interconnection, or a joint management agreement
39 between the systems.

40 **SECTION 4.4.(b)** The Program Evaluation Division shall submit its findings and
41 recommendations to the Joint Legislative Program Evaluation Oversight Committee and the
42 Environmental Review Commission at a date to be determined by the Joint Legislative
43 Program Evaluation Oversight Committee.
44

45 **PART V. SEVERABILITY CLAUSE AND EFFECTIVE DATE**

46 **SECTION 5.1.** If any section or provision of this act is declared unconstitutional or
47 invalid by the courts, it does not affect the validity of this act as a whole or any part other than
48 the part declared to be unconstitutional or invalid.

49 **SECTION 5.2.** Except as otherwise provided, this act is effective when it becomes
50 law.
