7	The General Assembly of North Carolina enacts:	
8	SECTION 1. G.S. 14-269.2 is amended by adding a new subsection to read:	
9	"(m) Notwithstanding any other provision of this section, a person who has a concealed	
10	handgun permit issued in accordance with Article 54B of this Chapter, has a concealed handgun	
11	permit considered valid under G.S. 14-415.24, or is exempt from obtaining a permit pursuant to	
12	G.S. 14-415.25 may carry a concealed handgun on educational property if the educational property	
13	is an institution of higher education as defined in G.S. 116-143.1."	
14	SECTION 2. G.S. 14-415.11(c) reads as rewritten:	
15	"(c) Except as provided in G.S. 14-415.27, a permit does not authorize a person to carry a

17	(1) Areas prohibited by <u>G.S. 14-269.2, 14-269.3, and 14-277.2.</u> <u>G.S. 14-269.3 and</u>	
18	<u>G.S. 14-277.2.</u>	
19	(1a) Areas prohibited by G.S. 14-269.2, except as allowed under G.S. 14-269.2(m).	
20	(2) Areas prohibited by G.S. 14-269.4, except as allowed under G.S. 14-269.4(6).	
21	(3) In an area prohibited by rule adopted under G.S. 120-32.1.	
22	(4) In any area prohibited by 18 U.S.C. § 922 or any other federal law.	
23	(5) In a law enforcement or correctional facility.	
24	(6) In a building housing only State or federal offices.	
25	(7) In an office of the State or federal government that is not located in a building	
26	exclusively occupied by the State or federal government.	
27	(8) On any private premises where notice that carrying a concealed handgun is	
28	prohibited by the posting of a conspicuous notice or statement by the person in	
29	legal possession or control of the premises."	
30	SECTION 3. This act becomes effective December 1, 2017. Prosecutions for offenses	
31	committed before the effective date of this act are not abated or affected by this act, and the	
32	statutes that would be applicable but for this act remain applicable to those prosecutions.
