SECTION 3. G.S. 20-81.12 reads as rewritten:
"§ 20-81.12. Collegiate insignia plates and certain other special plates.
(b155) Mayberry. – The applicable requirements of G.S. 20-79.3A shall be met before the
Mayberry plate may be developed. The Division shall transfer quarterly the money in the
Collegiate and Cultural Attraction Plate Account derived from the sale of Mayberry plates to the
Surry Arts Council to be used to provide support for the Council.
"
SECTION 4. The Revisor of Statutes is authorized to alphabetize, number, and
renumber the special registration plates listed in G.S. 20-79.4(b) to ensure that all the special
registration plates are listed in alphabetical order and numbered accordingly.
SECTION 5. This act becomes effective July 1, 2018.
